 - a. **We are open to having 1x facilitator who would be required as the in-person and the 2nd facilitator would need to be supporting throughout in a virtual capacity. This would be revisited every 6 months to determine if the situation or limitations have changed.**
2. **Relatedly, given the COVID climate concern, could you please advise what other cities are potentially available for training, if any, i.e., specifically Ottawa, Toronto, and/or Vancouver?**
 - a. **At this time we are holding firm on the geographical locations of CFB Gagetown and CFB Borden.**
