SOLICITATION AMENDMENT # 001

This solicitation amendment is raised to:

- 1. Address the following questions submitted during the solicitation period;
- 2. Extend the solicitation period;
- 3. Amend Appendix 1: Mandatory Criteria;
- 4. Amend Annex A Statement of Work of the RFP;
- 5. Amend Annex B Basis of Payment; and
- 6. Amend "Attachment 3.1 FinancialProposal.xlxs".

QUESTIONS AND ANSWERS

- Q1. For the Mandatory Criteria list below, can you clarify if our report is for a one-month period in the last twelve (12) months or a three-month period in the last twelve (12) months?
 - 1. For each region being bid on, the Bidder must demonstrate they have experience supplying and delivering a minimum number of orders of telephone and computer headset orders in a given one-month period
 - 2. In order to demonstrate this experience, the Bidder must provide an activity report that demonstrates this volume, covering a three-month period within the last twelve (12) months as of the date of bid closing
- A1. Mandatory Criteria E1 is stating that the experience being demonstrated for the orders is for any given one-month period within the last twelve (12) months.

For Mandatory Criteria E1, the one-month period is to be within the last (12) months as of the date of bid closing. The Mandatory Criteria in Appendix 1 of the RFP has been amended below to reflect this change.

- Q2. With regards to the following details "Connects directly to telephone and computer (adaptor), and also allows the use of an amplifier", will the headsets be connected via an amplifier of use a direct connect cord?
- A2. The wired headset must connect to telephone and computers (USB Type A and 3.5mm jack). All necessary adaptors to facilitate these connections must be provided at no additional cost. This has been reflected in the amendments to the SOW below.
- Q3. If the connection is done via a direct connect cord, we would need to have all the phone models that CRA are using. Is the adapter for the computer connection purchased separately?
- A3. The direct connect cord must connect to telephone and computers (USB Type A and 3.5mm jack), irrespective of phone model. All necessary adaptors to facilitate these connections must be provided at no additional cost. This has been reflected in the amendments to the SOW below.
- Q4. Since the headset requirement is a Quick Disconnect, will the USB adapter that is being requested be purchased separated?
- A4. If a USB adapter is required, it must be provided with the headsets at no additional cost. This has been reflected in the amendments to the SOW below.
- Q5. With regards to the following statement "Wired headset should connect to a computer by USB and must work with USB 2.0 and above with USB Type A" will the USB adapter be bought separately?



- A5. If a USB adapter is required, it must be provided with the headsets at no additional cost. This has been reflected in the amendments to the SOW below.
- Q6. Option for active noise cancellation: no Quick Disconnect headset have this capacity. Could CRA elaborate this requirement?
- A6. From our internal research we have found that there are headsets with both noise cancellation and quick disconnect, however, we do understand that no headset connected through an adaptor using 3.5mm jack will have noise cancellation capability. This has been reflected in the amendments to the SOW below.
- Q7. Where would a stand for the headsets need to be installed?
- A7. It should be a simple stand that would sit on top of any flat surface, and should not need to be mounted onto anything. Therefore, no installation should be required.
- Q8. Is the adaptor required to connect to a computer going to be purchased separately?
- A8. The wired headset must connect to telephone and computers (USB Type A and 3.5mm jack). All necessary adaptors to facilitate these connections must be provided at no additional cost. This has been reflected in the amendments to the SOW below.
- Q9. Will each Quick Disconnect headset need to come with a Y adapter?
- A9. The Y adapters would be purchased separately as a part of Section 4.0: Accessories for Existing CRA-Owned Headsets of "Annex A Statement of Work".
- Q10. Will each Quick Disconnect headset need to come with the 3.3.2 amplifiers?
- A10. The Y adapters would be purchased separately as a part of Section 4.0: Accessories for Existing CRA-Owned Headsets of "Annex A Statement of Work".

E1	 For each region being bid on, the Bidder must demonstrate they have experience supplying and delivering a minimum number of orders of telephone and computer headset orders in a given one-month period. The minimum number of orders for each region are as follows: a) 25 orders for the Ontario region; b) 10 orders for the Quebec region; c) 15 orders for the Atlantic region (Nova Scotia, Prince Edward Island, New Brunswick, and Newfoundland and Labrador); and / or d) 20 orders for the Western region (Manitoba, Alberta, Saskatchewan, and British Columbia) In order to demonstrate this experience, the Bidder must provide an activity report that demonstrates this volume, covering a one-month period within the last twelve (12) months as of the date of bid closing. This activity report must include: a) the quantity of orders supplied and delivered within the bid region; b) the order dates; and c) province of delivery. This report can include multiple clients serviced during this time period. A separate activity report demonstrating this experience must be provided for each region the Bidder is bidding on. 	




