This amendment is raised to answer bidders' questions.

QUESTIONS AND ANSWERS

Question 7:

Is there (or has there been) an incumbent providing these services to the CIC within the past 5 years?

Answer 7:

As indicated in the Notice of Proposed Procurement on the Canadabuy website, there is incumbent for this requirement. Please refer to the Description for the information.

Question 8:

In Attachment 4.1, the requirement MTC1 of the Mandatory Technical Criteria states that bidders may use: "up to two IM/IT contracts which provided Business Analysis and ERP Functional Analyst services..."

If bidders require the use of two separate IM/IT contracts, do both contracts require the supplying of both Business Analyst and ERP Functional Analyst resources on each contract? Or may bidders utilize one contract that supplied Business Analyst resources and another contract which supplied ERP Functional Analyst resources?

Answer 8:

Yes bidders can utilize one contract that supplied Business Analyst resources and another contract which supplied ERP Functional Analyst Resources.

Question 9:

In Attachment 4.1, the requirement MTC1 of the Mandatory Technical Criteria states that bidders may use: "up to two IM/IT contracts which provided Business Analysis and ERP Functional Analyst services, as described in Annex A Statement of Work (SOW) of this requirement, the Bidder must demonstrate experience for each reference contract as follows: (a) Must have been a contract with a single client;"

If bidders require the use of two contracts, do both contracts need to be from the same client? Or can the two contracts be from separate clients?

Answer 9:

The two contracts can be from separate client, but each contract has to be with a single client.

Question 10:

In Attachment 4.1, the requirement MTC1 of the Mandatory Technical Criteria states that bidders may use: "up to two IM/IT contracts which provided Business Analysis and ERP Functional Analyst services, as described in Annex A Statement of Work (SOW) of this requirement, the Bidder must demonstrate experience for each reference contract as follows: (b) Must have a minimum contract value of \$5 Million (not including amendments and applicable taxes);"

If bidders require the use of two contracts, do both contracts need to be of a minimum contract value of \$5 Million (not including amendments and applicable taxes)? Or would two contracts of which the sum of their contract value exceeded \$5 Million (not including amendments and applicable taxes) be accepted?

Answer 10:

Each contract must have a minimum contract value of \$5 Million (not including amendments and applicable taxes).
