TWO PHASE SELECTION PROCESS

This is the first phase (Phase One) of a two-phase process: the first phase will evaluate the qualifications of all interested suppliers; the second phase (Phase Two) will invite the qualified suppliers to provide a financial bid on the project based on the specifications and drawings. The qualification list will expire within 60 days or upon award of a contract in Phase Two, whichever is earlier, and the prequalification list will not be used in any other solicitation.

INSTRUCTIONS TO SUPPLIERS

1. TWO PHASE SELECTION PROCESS

Suppliers responding to this selection process are requested to submit in two phases. Phase One qualification covers only the qualifications and experience of the supplier. Following the evaluation of the submissions, suppliers will be advised of their qualification result and the status of the Phase Two tender. Phase Two suppliers will be provided an Invitation to Tender (ITT) for the financial evaluation in relation to the specifications and drawings.

Documents may be submitted in either official language of Canada.

PROJECT DESCRIPTION:

Work of this Contract comprises of the Living Units Door, Power and Lighting Control System upgrade for Buildings 5, 50, 51 and 58 for Corrections Services Canada, located at Springhill Institution, Springhill, NS; and further identified as Project R.116772.001.

Replacement of existing door and control management system in 4 buildings: Building 5, Building 50, Building 51 and Building 58 including:

- Removal of existing control and existing monitoring equipment located in each of these buildings.
- Install new monitoring workstation in existing Control post.
- Install new control and PLC cabinet in each existing communication room for each of the 4 x buildings.
- Upgrade existing system to allow the control and monitoring of existing lighting and receptacles load.
- Upgrade existing communication to allow remote monitoring in the existing Building 1.
- Upgrade the existing MCCP located in building 1 to integrate the new DCMS monitoring for Building 5, Building 50, Building 51 and Building 58.
- Commissioning, testing, training and demonstration of the new system.

The Contractor must perform and complete the Work by January 2025.

CONDITIONS TO QUALIFY:

At Phase One closing, the supplier must:

- a) comply with the following Mandatory Requirements; and
- b) provide the necessary documentation to support compliance.

MANDATORY REQUIREMENTS:

M1 - Door Control Management: Seven (7) years working experience in the provision of Door control management system for Canadian Federal Correctional Institution. This will be required for the main contractor or their subcontractors. The Bidder must provide two (2) reference projects within the past seven (7) years that reflects experience in the installation, integration, training and maintenance/service of Programmable Logic Controller (PLC) driven Door Control Systems in any of the following environments: Prisons, jails, detention centres, or equivalent correctional institutions

M2 - Detention Door Hardware Modifications: Detention door hardware modifications must be carried out by qualified and trained trades people regularly engaged in the installation, repair and/or maintenance of electro-pneumatic detention hardware. The proposed resource(s) must have realized at least two (2) projects within the last seven (7) years, with the installation, repair and/or maintenance of electro-pneumatic detention door hardware.

M3 - Procurement Business Number (PBN): Suppliers are required to have a Procurement Business Number (PBN). Suppliers may register for a PBN online at Supplier Registration Information.

Failure by the supplier to provide the required documentation in Phase One will result in the supplier being disqualified and no further consideration will be given to the supplier and the submission will be deemed non-responsive.
