This amendment is raised to revise the solicitation and to answer bidders' questions.

1. REVISION

9) At Attachment 4.2, 2.0 Resource Point-Rated Technical Criteria, RTC13:

DELETE: The Bidder should demonstrate that the proposed resource possesses any of the following certifications:

- SAP Certification as delivered by SAP;
- Project Management Professional (PMP);
- Accounting Designation (CPA).

A copy of the certification(s) must be included with the résumé

INSERT: The Bidder should demonstrate that the proposed resource possesses any of the following certifications:

- SAP Certification as delivered by SAP;
- Project Management Professional (PMP);
- Accounting Designation (CPA);
- ProSci Certification; or
- Prince2 Certification.

A copy of the certification(s) must be included with the résumé.

2. QUESTIONS AND ANSWERS

Question 15: With respect to RCT13 for the Change Management Consultant, page 129, could the Crown please confirm that a resource that possesses 3 SAP certifications, as delivered by SAP, would score full (3) points on this criterion, 1 point per SAP certification?

Answer 15: Canada confirms that a resource that possesses 3 SAP certifications, as delivered by SAP, would score full (3) points on this criterion, 1 point per SAP certification.

Question 16: For RCT13, Change Management Consultant, would the Crown accept a ProSci Change Management Certification or PMI Prince2 certification to score points?

Answer 16: Canada will revise the requirement for RTC13 and add Prince 2 and ProSci Certifications but the maximum points available will remain at 3. Please see the revision 9).

Question 17: With respect to RTC19 for the Project Manager role, page 133, would the Crown accept a relevant SAP Project Management certification such as ASAP or Activate rather than an accounting designation?

Answer 17: No, Canada will not accept ASAP or Activate in place of an accounting designation.

Question 18: We request an extension to the closing date to October 20, 2022.

Answer 18: Canada will not extend the closing date as requested.
