The amendment to the bid solicitation is to address the enquiries received:

Response(s) (R) to Question(s) (Q):

Q1: Although the bid is due tomorrow, it looks like in Amendment #2 that came out today, the client has moved the wrong table to the NSA section - it was supposed to be the laptop table, Line #7, however the table from Line #3 now appears to be under the NSA instead. Please provide clarification as it will effect products client wants and pricing on all bids.

R1: The laptop table is still to be part of the SA

Q2: Re. Item, 9. will the CA respectfully also accept a sled base?

R2: No we would like a full modesty.

Q3: Re. Item 9, will the CA respectfully also accept a plywood or laminate seat/back

R3: No sorry, we would like to see polymer and fabric.

Q4: In regards to Q2 released this morning:

Line # 11 -GoCUID# 6SMPRBXXLU25G19LYNN, looks to be intended to work with Line #10 - GoCUID# 6SMORBXXLU25G19LYNN, which is not a banquette or booth style application per the SA. It is more of a Lounge seating/bench requirement.

The client is asking for this to now be a 'booth style', however that is what is being asked for on Line 4 - GOCUID# 6SBATWXXLUW3G19LLYN, which called out in the SA as Banquette seating without bolster, with privacy screen.

Line 4 + Line 13 in NSA are labelled Huddle Type 2 - which would be the booth style product application.

If manufacturers change Line 11 to be a booth style application, it will no longer work with Line 10 and the GoCUID should be changed to reflect the different product as noted above for Line 4.

R4: Thank you for pointing this out. Items 4 and 13 are intended to go together as a booth style product application, with a privacy screen on the back of the booth seats. It should also include cushion on both the seat/back. Items 10, 11, 12 are intended to be lounge/ sofa type seating.

Q5: Line 8 & 9 - Kitchenette Table and Counter height stools:

GoCUID# 6CKIVAREGL48L96PYXX is a Bar height table - range of 41" - 43" height.

GoCUID# 6KBSCHxxLY15XXXPOYX are counter height stools which are shorter - 36"H approx. which is too short. Bar height stools are GoCUID# 6KBSBHxxLY15XXXROYX matching the same description of armless, with seat cushion, 4 leg.

R5: Thank you for pointing this out. We require Bar height stools - GoCUID# 6KBSBHxxLY15XXXROYX matching the same description of armless, with seat cushion, 4 leg.

Q6: As this is due tomorrow, would it be possible to also get email confirmation prior to the amendment release in the morning?

R6: No, all communication must be released to all bidders simultaneously.
