## ADDENDUM No. 2

The present addendum is raised to answer the questions below. This shall be read in conjunction with and shall form an integral part of the RFSO / Proposal and Agreement Documents:

Number	Questions	Answers
35	Section 2.7.1 e requires a QPESA to provide services related to soil and groundwater contamination. This individual and this experience do not appear to be rated/included anywhere in the proposal.	If your firm has access to one or employs one, we suggest it be mentioned.
36	Hydrogeology services are often required on projects with geotechnical components. Is hydrogeology required for the RFSO? How will it be considered in the evaluation?	A hydrogeologist is not required in this RFSO, but if your firm has access to one or employs one, we suggest it be mentioned.
37	For the concrete compressive strength testing item, is the Unit Rate for Year 1 (A) each 'cylinder' or each 'set'?	3 sets of 3 as per the unit price table

38	• Sampling and laboratory test unit costs will vary significantly depending on number of samples, type of tests and depth of sample collection (BH depth). Can the NCC please specify the minimum assumptions.	the consultant can qualify the unit rate based on pathways or roadways
39	• Traffic management costs are traditionally based on duration of the work, instead of length of segment. Would the NCC be willing to change the units to /hourly for this item?	hourly rate with a 3hr min
40	• Can the NCC clarify whether the contingency item for drilling equipment mobilization is for each individual call-up or for the entire SOA?	Each call up
41	RFSO states that we are to provide 4 CVs of in- house personnel who will perform the majority of services for call-ups, and only the first 4 CVs will be evaluated. Addendum 1 states that we can list additional staff, but are to indicate the 4 who will respond to this SOA. Will NCC please clarify the following: - Does NCC expect proponents to include CVs for a full roster of staff, beyond the 4 key personnel, to cover off each category level in their submissions in order to score well under Rated Requirement 4 evaluation criteria? - Per Addendum 1, Q&A 13, if all CVs are to be appended, what content does NCC expect evaluate under Rated Requirement 4 of the technical submission? - Are the appended CVs bound to the 3-page limit?	All cv's above a beyond the 1st 4 can be as many pages as you wish but in the appendix. An organizational chart would be ideal to understand the manner in which your firm operates. Just 4 cv's will be reviewed as part of the main submission.
42	Will the NCC provide an additional extension to review the latest addendum.	Yes, the closing date is not October 14, 2022 at 3PM EDT.
