This amendment is raised to:

- 1) Extend the bid tender closing date from October 14, 2022 to October 24, 2022
- 2) DELETE in its entirety: Solicitation Document M5000-22-03980C dated September 13, 2022 and INSERT Solicitation Document M5000-22-03980C dated for October 14, 2022
- 3) Respond to the following questions:

i) The panel matrix indicates that Panel Type B should have both laminate and fabric for the lower element. Please confirm which material is requested.

Lower Element for Panel Type B is Laminate

ii) Work surface Privacy panels can have a total height of 42" to 49", with a base panel and add-on panel. SA Specifications allow for power below or above work surface. The left image below shows power above the surface, the image on the right below the surface. In the provided image, both power locations are in the lower element on the base panel.

Power location should be as shown in the right image.

iii) The floor plan provided does not show the location of the height-adjustable tables. Please advise, noting that if a fixed surface is placed in front of a height-adjustable surface the sizes dictated by the SA specs do not allow for the 1" safety gap that is required. To solve this, the height-adjustable table would have to be reduced in depth by an additional 1", making the actual depth of a 24 table 22". Secondly, surfaces in the RFB do not appropriately fill the space in the panel layout provided. There would be a dead space of approximately 13" in the corner of the workstation. Please confirm the correct layout and location of all surfaces.

iv) The panel matrix chart in the RFB has a total of 67 Base panels, and 60 add-on panels. If all the panels on the floor plan are to be the same height, then the total base must be the same as the total add-on.

The CAD floor plan provided shows a total of 64 panels in the design. To match the panels in the floorplan the quantities in the chart below would need to be adjusted

v) *Workstations "4/5/6/7/8/9" are grouped with a total of 15 duplexes (30 simplex outlets). This is above the maximum 6 duplexes per circuit allowable. Therefore 3 circuits would need to be*

connected to the one base feed to avoid overloading this grouping. Likewise, workstations groupings "10/10/11/12" and "1/2/3" would require 2 circuits attached to 1 base feed.
