Solicitation amendment 003 is issued to answer questions from bidders.

Q1: Do we need to replace the metal panels?

A1: All metal cladding requires replacement.

Q2: Do we need to replace each plates between windows?

A1: All metal cladding requires replacement.

Q3: Can you please specify the type, thickness, profile of the new metal flashings?

A3: The intent is to perform a re and re of existing. The gauge of metal could have been measured on site during the job showing. I assume its 12 – 16 gauge, however, it would be best to take measurements physically. I can accommodate an subsequent site visit if required.

Q4: Documents specify that work needs to be done after hours (6pm to 6 am or weekends). Do we need to include lights, generators to perform night work?

A4: The client has approved the work during regular working hours, however they reserve the right to cease any work should noise or smell disrupt client operations.

Q5: Could you please give a more detailed scope of work?

A5: Remove existing, and provide and install new metal cladding, trim(hook), and sealant for the skylight of the Bank of Nova Scotia.

Q6: Can you please specify if work can be done in summer 2023?

Q7: As no work will be performed during the fall/winter, we would like to commence this work as early as spring 2022. We believe this is a reasonable time line to accommodate the logistics of the project.
