#### **SOLICITATION AMENDMENT # 004**

#### This solicitation amendment is raised to:

- 1. Address the following questions submitted during the solicitation period;
- 2. Amend "Annex A Statement of Work";
- 3. Change references to "computer and telephone headsets" throughout the RFP;
- 4. Remove references to "wired headsets" throughout RFP;
- 5. Amend Section 4.2 Steps in the Evaluation Process;
- 6. Amend "Appendix 3: Financial Proposal";
- 7. Amend Annex B Basis of Payment;
- 8. Add products to the attachment "Attachment 3.1 FinancialProposal.xlxs"; and
- 9. Modify details of the attachment "Attachment 3.1 FinancialProposal.xlxs".

#### **QUESTIONS AND ANSWERS**

- Q1. Does CRA means the 3.5mm/QD cord and the USB-A/QD processor needs to be packaged and included with the QD Headset? Is CRA expecting one SKU for all 3 items?
- A1. Yes, this is correct and CRA is expecting one SKU for all 3 items.
- Q2. Given the level of late penalties CRA intends to levy, vendors will be required to stock products to ensure timelines are met. Can CRA please provide addition information on the volume of headsets required for this contract?
- A2. We cannot predict future usage of the resulting contract; however, based on transactional data available, the CRA issued approximately 391 headset orders, Canada-wide, per month between April 2021 to April 2022. This data is for informational purposes only.
- Q3. You have asked for a headset that connects to a telephone, a computer and a 3.5mm jack at "no additional cost." Do you wish for us to bundle a traditional amplifier (M22 for phone), a USB amplifier (computer) and a 3.5 mm (cell phone) into each category?
- A3. No, the amplifier is not required to be included with all headsets. We have added rows in Table B of the attachment "Attachment 3.1 FinancialProposal.xlxs", to account for amplifiers that are compatible with the new headsets.
- Q4. MSRP for the products being specified is only available in US dollars. Are we to convert the MSRP price to Canadian dollars? If so, at what exchange rate?
- A4. The MSRP can be proposed in USD, or other currencies if required. We have added a column to Table B of the attachment "Attachment 3.1 FinancialProposal.xlxs", to request the currency in which the MSRP is being provided in. If the MSRP is any currency other than Canadian the currency exchange rate published by the Bank of Canada on the solicitation closing date will be used for the conversion. This conversion will be done upon the solicitation closing date and will be the conversion rate that is used in the evaluation of the financial proposal and the Basis of Payment in the contract.
- Q5. You have asked for a link to the published MSRP but no such link exists, especially for Canadian prices. Even in USD there is only a "starting at" price published that does not accurately reflect what is being asked for by the CRA.
- A5. This has been removed from the attachment "Attachment 3.1 FinancialProposal.xlxs", CRA will reserve the right to request documentation on the published MSRP (manufacturer, model number, and MSRP) prior to contract award. See amendment to Section 2.2 Steps in the Evaluation Process.

- Q6. Is shipping to be included in the price? If yes, will these be ordered as single units and shipped to home addresses?
- A6. Yes, shipping must be included in the price and these will be ordered as single units and shipped to CRA office locations and home addresses.
- Q7. You have asked for a blanket discount off MSRP for the core products however each product asked for is priced using different formulas to the resellers. Is it possible to separate the discount by product? This would allow the resellers to give each product the best possible price without having to guess a "middle of the road" discount for all products.
- A7. We will not be separating the MSRP discount, the discount off of the MSRP must remain the same for all products.
- Q8. Does the CRA simply want the lowest cost compatible headset or will build quality, organizational standardization and call security be taken into account? At present, it seems like the CRA is at risk of standardizing on "knock-off" headsets. The CRA has standardized on Plantronics/Poly headsets for the past 30 years. Is it safe to assume you wish to remain with that manufacturer?
- A8. Please see Part 4 "Evaluation and Selection" of the RFP for details on the selection methodology of this RFP.

- 7. DELETE Section 5.0 of "Annex A Statement of Work" of the RFP in it's entirety.
- 8. Throughout the RFP, DELETE any mention of "telephone headsets" and "telephone and computer headsets" and REPLACE WITH "computer and telephone headsets".
- 9. Throughout the RFP, DELETE any mention of "wired headset" and REPLACE WITH "headset".
- 10. DELETE "Section 4.2 Steps in the Evaluation Process" in it's entirety and REPLACE with:

The selection process to determine the successful Bidder will be carried out as follows:

Notwithstanding Steps 1 and 2 below, in order to expedite the evaluation process, CRA reserves the right to conduct Step 3 - Evaluation of Financial Proposals concurrently with Steps 1 and 2. Should CRA elect to conduct Step 3 prior to the completion of Step 2, the information in the Financial Proposal will not be disclosed to the team evaluating the mandatory and rated sections until the completion of Steps 1 and 2. However, if the Contracting Authority is able to ascertain that a proposal is non-responsive by virtue of incomplete information or an error in the financial proposal, the Contracting Authority will advise the team evaluating the mandatory and rated sections that the proposal is not compliant and should no longer be considered. The concurrent evaluation of the financial proposal does not in any way construe compliance in Steps 1 and 2 despite the statement "All bids meeting the minimum thresholds in Step 2 will proceed to Step 3".



Bids will be ranked in accordance with the Selection Methodology.

#### Step 1 - Evaluation against Mandatory Criteria

All bids will be evaluated to determine if the mandatory requirements detailed in Appendix 1: Mandatory Criteria have been met. Only those bids meeting ALL mandatory requirements will then be evaluated in accordance with Step 2 below.

#### Step 2 - Evaluation against Point-Rated Criteria

Technical bids will be assessed separately against the evaluation criteria identified below. Point-rated criteria not addressed in the bid will result in a score of zero being assigned against that particular criterion.

# **Step 3 – Evaluation of Financial Proposals**

Only technically compliant bids meeting all of the requirements detailed in Steps 1 and 2 will be considered at this point.

Prices submitted will be evaluated to determine the bid evaluation score for each region as defined in Appendix 3: Financial Proposal. Once the bid evaluation scores for each region are determined under Step 3, the proposals will proceed to Step 4.

Bidders must provide a price, percentage, or weight, as applicable, for each item identified in the format specified in Appendix 3: Financial Proposal. Ranges (e.g., \$10-\$13) are not acceptable.

# Step 4 - Basis of Selection

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive.

The Bidder with the highest ranked responsive bid in each Region and meeting all the requirements listed above will be recommended for award of a contract for that Region.

Each Region will be evaluated separately.

SACC Manual Clause <u>A0027T</u> (2012-07-16), Basis of Selection – Highest Combined Rating of Technical Merit and Price

- 1. To be declared responsive, a bid must:
  - a. comply with all the requirements of the bid solicitation; and
  - b. meet all mandatory criteria.

Bids not meeting (a) or (b) will be declared non-responsive.

- 2. The bids will be ranked by CRA based on the highest responsive combined rating of technical merit and price. The ratio will be 20% for the technical merit and 80% for the price.
- To establish the technical merit score, the overall technical score for each responsive bid will be determined as follows: total number of points obtained / maximum number of points available multiplied by the ratio of 20%.
- 4. To establish the pricing score, each responsive bid will be prorated against the lowest Final Bid Evaluation Score and multiplied by the ratio of 80%.



- 5. For each responsive bid, the technical merit score and the pricing score will be added to determine its combined rating (Final Bid Evaluation Score).
- 6. Neither the responsive bid obtaining the highest technical score nor the one with the highest Bid Evaluation Score will necessarily be accepted. The responsive bid with the highest combined rating of technical merit and price will considered the highest ranked responsive bid. The other bids will be ranked accordingly.

The table below illustrates an example where all three bids are responsive and the selection of the contractor is determined by a 20/80 ratio of technical merit and price, respectively. The total available points equals 135 and the highest Bid Evaluation Score is 45.

The Bidder with the highest total combined rating in each Region will be considered to be the highest ranked responsive bid for that Region and, subject to meeting the conditions precedent to Contract award outlined in Step 5, will be recommended for award of the Contract.

# Step 5 - Proof of Synergy 2.0 Compliance (PoSC)

The highest-ranked responsive Bidder in each Region will undergo Proof of Synergy 2.0 Compliance testing (PoSC) prior to contract award, as described in section 5 of Appendix 1 to Annex C: Synergy Solution. The CRA reserves the right to test the proposed solution in whole or in part against all of the PoSC test requirements set out in Appendix 1 to Annex C: Synergy Solution.

Claims of future compliance with CRA's Synergy 2.0 requirements in software or hardware releases will not be considered.

## Step 6 - Conditions Precedent to Contract Award

The Bidder(s) recommended for award of a Contract must meet the requirements provided in Part 5 "Certifications and Additional Information" of this RFP.

# Product Certification and MSRP Validation

The CRA may request that the Bidder provide all required supporting documentation to demonstrate compliance of the proposed products with the requirements outlined in Annex A. Supporting documentation



may include but is not limited to brochures, specification sheets, diagrams, product guides, and test reports. In the event that the CRA makes such a request, the Bidder must provide the Contracting Authority with the required documentation within five (5) business days.

The CRA may also request that the Bidder provide supporting documentation to demonstrate the MSRP pricing provided by the Bidder in their financial proposal. Supporting documentation may include but is not limited to a URL to the published MSRPs, brochures, product guides, or correspondence signed by the OEM. In the event that the CRA makes such a request, the Bidder must provide the Contracting Authority with the required documentation within five (5) business days.

Bidders are encouraged to submit their supporting documentation as soon as possible after the request by the Contracting Authority to provide every opportunity to ensure that all required information has been received by the end of the prescribed period. If desired, bidders may submit their supporting documentation with their bid at the time of bid closing.

Failure to provide the necessary supporting documentation within the specified timeline shall render the bid non-compliant, and the CRA will invite the Bidder with the next highest ranked responsive bid to participate in the Product Certification and MSRP phase of the evaluation.

Bidders are invited to include their supporting documentation within their bid.

#### Step 7 - Contract Entry

The Bidder(s) with the highest ranked responsive bid in each region and meeting all the requirements listed above will be recommended for award of a contract for that region.

In the event that a single Bidder is deemed the highest ranked responsive bid for two (2) or more regions, the CRA will award one (1) contract to this single Bidder for the regions in which they are the highest ranked responsive bidder.

# 11. DELETE "Appendix 3: Financial Proposal" in it's entirety and REPLACE with:

#### 1. General Instructions

Bidders must complete Attachment 3.1 FinancialProposal.xlsx provided as an electronic attachment to this requirement, in accordance with the instructions below. For each region in which the bidder chooses to submit a bid fill in the applicable tab in the spreadsheet.

Where a product a not available on the bidder's product offering list, the Bidder must propose a price for an alternate brand item that meets or exceeds the same specifications. The Bidder must provide any alternative items in accordance with Section 2.7 of the RFP.

# 2. Electronic Processing of Financial Offer Template

Attachment 3.1 FinancialProposal.xlsx will be processed for evaluation by CRA using electronic automation. As such, Bidders must not change the format or rename the attachment in any way. At the time of evaluation, if the completed attachment submitted by the Bidder has been reformatted or renamed in a way that prevents automated processing, the bidder may be found non-responsive.

#### 3. Field Color

All pink coloured fields (Table A: Cells B7:11, Table B: Cells D18:G37, Table C: Cells D45:E67) must be populated by the Bidder in compliance with the instructions below.

#### 4. Prices

The prices specified, when quoted by the Bidder, include all of the requirements defined in the "Statement of Work" in Annex A.



Shipments shall be consigned to the destinations specified in Annex A and Delivered Duty Paid (DDP) (all CRA locations listed at Annex A-1 of the Statement of Work and employee home addresses) Incoterms 2010 for shipments from a commercial supplier.

The Contractor will be responsible for all delivery charges, administration, costs and risk of transport and customs clearance, including the payment of customs duties and taxes.

## 12. At "Annex B - Basis of Payment" of the RFP, DELETE the table in it's entirety and REPLACE with:

The Contractor will be paid firm all-inclusive unit prices, in Canadian Dollars, DDP Destination (address listed on individual task authorizations), Customs Duties and Excise Taxes included, where applicable, GST/HST extra, as applicable, including transportation, for the supply and delivery of computer and telephone headsets and accessories on an "as and when requested" basis. Shipments shall be consigned to the destinations specified in Annex A-1 and Delivered Duty Paid (DDP) (all CRA locations listed at Annex A-1 of the Statement of Work and employee home addresses) Incoterms 2010 for shipments from a commercial supplier.

The Contractor will be responsible for all delivery charges, administration, costs and risk of transport and customs clearance, including the payment of customs duties and taxes.

The firm all-inclusive unit prices will be established as follows:

- 1. For the items included in Appendix 3: Financial Proposal, the Minimum Discounted Prices calculated in accordance with Appendix 3: Financial Proposal; and
- 2. For any additional items added to the contract, the firm all-inclusive unit prices will be established by applying the minimum percentage discount to of the MSRP as offered by the Contractor within Appendix 3: Financial Proposal to the MSRP at the time of adding the additional item.
