This amendment 002 is raised to:

- a) Answer questions;
- b) Modify the bid closing date;
- c) Modify the product table and description of items for Category 6.



a) Questions and Answers

- 1. For table 1 Category 6, item 16 - can we bid a 4 leg stool vs a sled base stool?

No. The GoCUID for this item indicates sled base.

- 2. Can you please give us an extension for the submission of the above mentioned solicitation?

Yes. The new bid closing date is October 27th, 2022 at 2:00 pm EDT.

- 3. Category 6 item #2: I have a question regarding the required size of the item. Table 1 – Product Table Page 17 item #2 indicates table is required to be 30”W x 60”L x 29”H. On page 18 under Description of items- Category 6 the required dimensions are 36” D x 66”W. Could you please confirm which size is required for this item?

This item has been replaced by GoCUID # 6MMTMDREOL30L60WYN. Dimensions are as per indicated in the SA.

- 4. Category 1B Item 1, will you accept a frameless PET-Felt privacy screen?

Yes, that is acceptable

- 5. Category 5 Item 8, will you remove the task lights and place them under its own award table as they are stand-alone products and not integral to the operation of the other CAT1/2 components?

No.

- 6. CAT5 item 8, please advise the maximum support weight per monitor.

Maximum weight per monitor is 10 pounds, based on Samsung 24” monitors

- 7. Under categories 1b, 2 and 5, NSA Item #10, for the 5 open-sided (3 workstations) units, as they are all facing a wall, is a privacy screen required?

These units are along the perimeter window wall, a privacy screen against that area is not required. Partitions between work stations are needed, but not along the window wall.

- 8. Category 6 Item 9, the GoCUID is for a Sofa but the description says no back with arms. This is not possible. Please accept standard specifications per the SA with a back or remove this item and procure it separately.

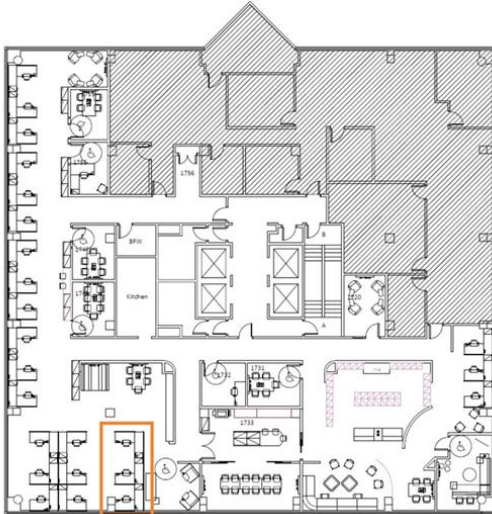
We will accept the standard with arms.

- 9. For Table 1 CAT 6 Items 10 & 11 – can you clarify if the fixed base can have lockable casters.

No. The SA indicates “with legs”.

10. Table 1 Cat 5 Non SA – Item 10 – is there 3 existing stations? Can you please confirm total of Item 10?

The three workstations encircled in orange (see image below) are height-adjustable on both sides. The quantity for Table 1- Cat 1b, 2, and 5- Non SA Item 10 is correct.
