- 2) DELETE Table 1 and INSERT Table 1 as attached to this amendment
- 3) Respond to the following questions:
 - i) Will end-user accept plastic laminate tiles as noted, but with the electrical/data cut outs in the panel bases? Yes
 - ii) Table 1, Cat 1B, item 5 Overheads:

The description in the re-issued RFB table remains the same as previous, listing Up Mounted as the mounting method, but the GoCuid has been changed to 1bHOOAN15L36XXXXXX, which indicates a panel mounted overhead. Up Mounted is the correct application as per your specification and drawings, please clarify GoCuid.

iii) Move Up mounted Overhead to spine panel, above fixed (panel mounted) work surface. This requires panels along spine to be 36" wide instead of 48" and 24" as shown in RFB plan.

iv) Table 1, Cat2: The new plan provided by you in the last message shows that all height adjustable tables (HAT) within the workstations are nominal 72" wide x 24" deep, with a qty of 16 shown on the floor plan, however the RFB lists a qty of 16 HAT that are 60" wide x 24" deep. Please clarify GoCuid and description.

vii) There is a quantity of 1 HAT 72" w x 30" d which appears to be for room 105. The original plan showed this as a fixed height D-top. This requires the balance of the desk to be made differently. To request the appropriate items please amend

Answer – The D Top has been removed from the RFB. GoCUIDs 1bFFHREG24L42WNOLNY and 1bFFHREG24L66WNOLNY complete this configuration.
