

# Advance Procurement Notice for UPS Replacement Batteries for Rack Mounted and Stand Alone UPSs

For Shared Services Canada (SSC)

Date of Issuance: April 21, 2022 (re-issued October 31, 2022)

#### **PURPOSE**

The aim of this advance notice is to **inform** interested **original equipment manufacturers** (OEMs) of UPS batteries and OEM's approved resellers that Shared Services Canada (SSC) will be publishing a solicitation in November 2022 for replacement batteries for UPSs meeting one or more of the following characteristics:

- rack mounted single phase, 5kVA capacity or greater
- rack mounted three phase 5kVA capacity or greater
- stand alone single phase 5kVA capacity or greater
- stand alone three phase 5kVA capacity or greater.

The replacement batteries will be delivered to sites across Canada.

#### **BACKGROUND**

Shared Services Canada (SSC) provides consolidated information technology, network, and telecommunication services to the Government of Canada. SSC supports UPS facilities across Canada, including through the provision of replacement UPS batteries.

SSC will soon be soliciting OEMs and OEM authorized resellers in order to provide the federal government with replacement batteries for UPSs meeting one or more of the following characteristics:

- rack mounted single phase, 5kVA capacity or greater
- rack mounted three phase 5kVA capacity or greater
- stand alone single phase 5kVA capacity or greater
- stand alone three phase 5kVA capacity or greater

(all together referred to here forth as "UPS Replacement Batteries").

Together with the delivery of UPS Replacement Batteries, OEMs and OEM authorized resellers may be require to provide: (1) installation services; and/or (2) recycling of used UPS batteries.

The procurement process is intended to be **inclusive** and provide the federal government with access to a broad range of suppliers across Canada.

#### **NOTABLE**

Some aspects of the upcoming solicitation that may be of interest to OEMs and OEM authorized resellers of UPS batteries are as follows:

1 – SSC intends to use the resulting supply vehicle from the upcoming solicitation to **compete** for **UPS Replacement Batteries** for SSC, its partner departments, and mandatory clients, at various Canadian locations.

A list of SSC' partner departments can be found in Annex A at the bottom of this document.

2 – Procure to Pay (P2P) is an integral part of SSC's contracting processes where all SSC requirements and solicitations are posted and managed. Registering for an account will allow vendors to **view**, **bid**, **invoice**, **and manage** opportunities with SSC. Resources are available to assist your business with account setup and support.

- 3 As **UPS Replacement Batteries** will be installed as part of a system, prequalified vendors will be required to provide information about the conformity of the new UPS battery(ies) within the affected UPS, including but not limited to original OEM documentation confirming that the installation of the new UPS battery is compatible with the targeted UPS.
- 4 The resulting supply vehicle will be used to either 1. to **deliver** the **UPS Replacement Batteries** to a specific cross-Canada location; or 2. to **deliver and install** the **UPS Replacement Batteries** at a specific cross-Canada location. The vendor could be required to **recycle** the used UPS battery(ies), which could involve the vendor arranging and paying for their delivery to the recycling facility approved or selected by Canada. Prequalified vendors intending to offer for the delivery and installation/removal services **may** be required to hold a valid Government of Canada Facility Security Clearance at the level of **Enhanced or Secret** and provide a completed and executed **Covid-19 Vaccination Requirement Certification** prior to submitting their offer for a specific UPS battery.

An example of the current Covid-19 Vaccination Requirement Certification can be found in Annex B at the end of this document.

5 – The solicitation will include a **refresh provision** whereby new OEMs and OEM authorized resellers of UPS batteries may seek prequalification at any time.

Canada shall not be bound by anything stated herein. Canada reserves the right to change at any time, any or all parts of the requirement, as it deems necessary. Canada also reserves the right to revise its procurement approach, as it considers appropriate, either based upon information submitted in response to this advanced notice or for any other reason it deems appropriate.
