ITEM 1: Solicitation Closing date per Amendment 002: November 22, 2022 at 14:00 CST

ITEM 2: Questions and Answers

1. The RFP identifies that the Proponent is to submit a Lump Sum Fee for the project which includes Phase 1 Energy Study / GHG and Phase 2 Engineering / construction Phase as a Single Dollar value with no separation of costs between Phase 1 and Phase 2 of the proposed project. Phase 1 of the project as described must be completed prior to determining the level of Professional effort and Fees along with the Professionals that make up the Team for Phase 2. Would PWGSC consider revising the RFP to request fees for Professional Services for Phase 1 only at this time?
 1. **Answer - The contract will be initially awarded for Phase 1A and 1B work only. A lump sum price should be provided individually for all phases based on the information known at this time. The pricing for Phases 2 and 3 may change based on the information collected and the options chosen at the end of Phase 1. The pricing for the later Phases is expected to change as the scope of the project is fine-tuned through the initial study. The SRE will be updated to reflect the pricing for each phase.**

2. In SRE 3 Article 3.1.2 Consultant Team Identification – this article Identifies several professionals that “Must” be part of the Proponents Team. For Phase 1 of the RFP some of the identified professionals would not be required to complete the Phase 1 Study as defined in the RFP. Would PWGSC consider revising the requirement to only the professionals deemed necessary to complete Phase 1 of the Proposed project?
 2. **Answer - The team members for the team through all Phases should be presented, additional page allotments were added to the SRE to accommodate the inclusion of these team members.**

3. Will existing drawings, Construction Specifications and O&M manuals be made available during the Proposal Stage so the consultants will have a general idea of the existing systems and general operations of same?
 3. **Answer – The requested documents will be presented to the successful firm.**

6. The schedule for Phase 1 of the proposed project is very limited. Would PWGSC consider extending this schedule or is it driven by fiscal year end reporting ?
