AMENDMENT 004

This amendment is raised to:

A) Answer questions from bidders;

B) Addition of a Solicitation Attachment document.

A. QUESTIONS AND ANSWERS

Q42: Where should we include for paint removal of wood in the breakdown table?

A42: The instruction to "restore" or "replace" includes surface prep and painting.

Q43: Where should we include for restoration of wrought iron shutters and new copper-clad shutters in the breakdown table?

A43: Refer to revised Appendix 1 Combined Price Form issued with Addendum #3.

Q44: As per section 08 06 00, there is no scope mentioned for the frame of windows (RW2-28 to RW2-35), could you please clarify the intent?

A44: Refer to revised Section 08 06 00 Intervention Work Sheets issued with Addendum #4.

Q45: Where should we include for paint removal of metal in the breakdown table?

A45: The instruction to "restore" or "replace" includes surface prep and painting.

Q46: In the specification 04 03 43.16, 3 quarries are specified for supply limestone similar to Kingston limestone. Our stone shop has contact with them, some of them don't supply limestone block anymore. We used Flinthills limestone (light & grey, see attached photos) to match Kingston limestone on previous jobs. Will the stone be acceptable with this approved alternative?

A46: On issuing this tender, the quarries listed in the specification confirmed availability of stone supply.

Q47: Would it be possible to clarify where the shallow surface delamination repairs are localized (as per detail 9/S402, addendum 2)? Is it a below arcade balcony slab or it is a concrete stools? What is the existing topping which has to be removed/restored?

A47: Refer to 6/S500 and 10/S502.

Q48: As per specs we have to clean all pigeon droppings (note CL on S200...S206) but the limits (zones) are not specified on the elevations. Could you please indicate the approximate area of bird droppings cleaning which should be included in our quote?

Would it be possible to precise the type of bird droppings cleaning – will It be a chemical removal, low pressure micro-abrasive cleaning or something else considering that the pricing for each type of cleaning is different.

A48: Cleaning of the bird droppings is located on the skyward facing surfaces. Assume for pricing pigeon droppings. Refer to specification 04 03 01.13 for cleaning method. An increased level of effort is required to clean pigeon droppings. No additional types of cleaning are required.
