Respond to Questions 2-6;

Q2 (Category 2): The specification for C-legs is too limiting. Please allow bidders to also use T-legs, as the SA does not limit leg types, and this would prevent suppliers with SA compliant product from bidding. Our T-leg provides the required leg clearance while maintaining stability of the table. As the bases require flexibility, the t-leg also allows for multiple depths of surfaces.

A2: OSFI is removing the C-Leg specification. This change is reflected in the amended table below.

Q3 (Category 3): The addition of a one-foot base cannot be provided with lockers on the SA as it is not included in the Annex A-1 specification details. To have lockers raised up by one foot, it is recommended that a contractor build a platform floor, and lockers can be installed on top of the platform

A3: OSFI is removing the additional requirement of a one-foot base. This change is reflected in the amended table below.

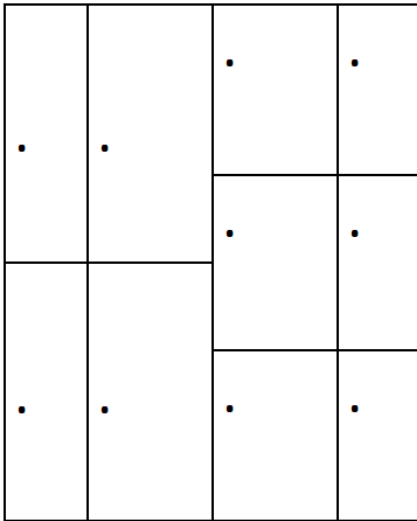


Q4 (Category 3): As an alternative to the platform recommendation, the lockers can be specified with the post legs described in the SA specifications "3.4.5.5.1 ...four (4) post legs no higher than 76mm (3 in.)" If the lockers were made NSA, we could safely provide post legs up to 6" tall.

A4: As mentioned in A3, OSFI is removing the requirement for an additional base.

Q5 (Category 3): Please provide a plan of how these lockers will be grouped together.

A5: Please see image of grouping below. Note that this is for illustrative purposes only.



Q6. (Category 3) Would you like the 2 high and 3 high lockers to be the same overall height? The SA specifications are between 48" and 66" high... please indicate which height you would prefer and if it the same or different for the two locker types.

A6. Yes, the 2 high and 3 high lockers must be the same overall height. For the height, it must be within the range of 60"-66". This change is reflected in the amended table below.

**** Modifiable Bases**

Canada is requesting bidders: to provide drawings and/or pictures including descriptive literature demonstrating how this product is made and could easily be adjusted or further modified to support surfaces ranging from, at minimum, 48in to 72in wide.

OSFI's intent is to, at OSFI's discretion, be able to modify the height adjustable base in the future for use in other projects which may require different width surfaces to what is defined here. We are looking to be able to re-use the existing mechanisms for surfaces ranging, at minimum, from 48in wide to 72in wide (depth would remain 30in).

Should OSFI decide to modify those height adjustable bases OSFI understands doing such modifications may void warranty and takes full responsibility.
