### **Question 1**

Annex B – 3.4.1 Webbing

Due to the short solicitation closing window, can you please let us know if a substitution of the webbing (particularly for color, elongation, and yarn properties) is acceptable for the pre-award sample; if we include a letter addressing the material will be strictly in accordance with the technical requirement outlined in Annex B should we be awarded the contract?

Will this be considered two infractions?

Alternatively, we are able to provide the specified webbing, however we will require additional time to receive the material. In which case we would like to request a 4 week extension.

### **DND Response (Q1)**

Please refer to Annex C, paragraph 2.2.5:

**2.2.5 MATERIAL SUBSTITUTIONS.** In the event that a component, that may include items such as metal fittings, is not available to the bidder in the time frame to manufacture the physical samples, the bidder may use a similar substitute component, on the condition that a letter addressing the substitution is submitted with the samples, together with a statement that, should the bidder be awarded the contract, all materials will be strictly in accordance with the technical requirement outlined in Annex B.

The substitutions will not be considered infractions.

A 4 week extension is granted.
