B) Answer the bidders' questions.

Question 1

- a) I have reviewed the RFP for CCDI 2023 2027. I was curious if any work has been done to date for 2023 as the timelines for a large event seem very tight?
- b) Would you accept bids for 2024 2027 with the concern that timelines for 2023 are unattainable?

Any insight into the work done for 2023 will be very helpful in our evaluation process.

Answer 1

- a) The Contractor is required to complete the scope of work within the timelines described in the Statement of Work (please see Annex B). In preparation for CCDI 2023, ESDC has initiated and completed other work and preparations for CCDI 2023, not included in the Statement of Work.
- b) Unfortunately, we cannot accept conditional bids. Subsequent CCDI events (2024, 2025, 2026, and 2027) are dependent on the successful completion of CCDI 2023 and are only to be provided to the Contractor if Canada decides to exercise the option periods.

All other terms and conditions of the solicitation remain the same.
