

#### 1.1 Security Requirements

## 2.1 Standard Instructions, Clauses and Conditions

- B. Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.
- C. The <u>2003</u> (2022-03-29), Standard Instructions Goods or Services Competitive Requirements, are incorporated by reference into and form part of the bid solicitation, with the following modification(s):

#### 2.2 Submission of Bids

A. Bids must be submitted only to the Department of National Defence (DND) the date, time, and place indicated on page 1 of the bid solicitation.

B. Due to the nature of the bid solicitation, bids transmitted by facsimile will not be accepted.

#### 2.2.1 Electronic Submissions

A. Individual e-mails that may include certain scripts, formats, embedded macros and/or links, or those that exceed five (5) megabytes may be rejected by Canada's e-mail system and/or firewall(s) without notice to the Bidder or Contracting Authority. Larger bids may be submitted through more than one e-mail. Canada will confirm receipt of documents. It is the Bidder's responsibility to ensure that their entire submission has been received. Bidders should not assume that all documents have been received unless Canada confirms receipt of each document. In order to minimize the potential for technical issues, bidders are requested to allow sufficient time before the closing date and time to confirm receipt. Bid documents submitted after the closing time and date will not be accepted.

## 2.3 Enquiries - Bid Solicitation

- A. All enquiries must be submitted in writing to the Contracting Authority no later than 15 calendar days before the bid closing date. Enquiries received after that time may not be answered.
- B. Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.


### 2.4 Applicable Laws

- A. Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario OR [insert the name of the province or territory].

- B. Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.
- C. Canada requests that Bidders follow the format instructions described below in the preparation of their bid:
  - (i) Use 8.5 x 11 inch (216 mm x 279 mm) paper; and
  - (ii) Use a numbering system that corresponds to the bid solicitation

#### 3.2 Section I: Technical Bid

A. In their technical bid, Bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

#### 3.3 Section II: Financial Bid

A. Bidders must submit their financial bid in accordance with the Pricing Schedule detailed in Attachment 1 to Part 3.

#### 3.3.1 Electronic Payment of Invoices - Bid

- A. The price of the bid will be evaluated as follows:
  - (i) Canadian-based bidders must submit firm prices, Canadian customs duties and excise taxes included, and Applicable Taxes excluded; and
  - (ii) Foreign-based bidders must submit firm prices, Canadian customs duties, excise taxes and Applicable Taxes excluded. Canadian customs duties and excise taxes payable by Canada will be added, for evaluation purposes only, to the prices submitted by foreign-based bidders.
- B. Unless the bid solicitation specifically requires bids to be submitted in Canadian currency, bids submitted in foreign currency will be converted to Canadian currency for evaluation purposes. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue, whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.
- C. The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

## 5.1 Certifications Required with the Bid

A. Bidders must submit the following duly completed certifications as part of their bid.

If any of these required certifications or additional information is not completed and submitted as requested, the Contracting Authority will inform the Bidder of a time frame within which to provide the information. Failure to provide the certifications or the additional information listed below within the time frame specified will render the bid non-responsive.

#### 5.2.1 Integrity Provisions - Required Documentation

#### ARTICLES OF AGREEMENT

## 6.1 Security Requirements

A. There is no security requirement applicable to the Contract.

#### 6.2 Requirement

A. The Contractor must provide the item(s) detailed under the Requirement at Annex A.

## 6.2.1 Optional Goods

- A. The Contractor grants to Canada the irrevocable option to acquire the goods, services, or both described at Annex A Requirement, of the Contract under the same conditions and at the prices and/or rates stated in the Contract. The option may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.
- B. The Contracting Authority may exercise the option at any time before the expiry of the Contract by sending a written notice to the Contractor.

## 6.3 Standard Clauses and Conditions

A. All clauses and conditions identified in the Contract by number, date and title are set out in the <u>Standard Acquisition Clauses and Conditions (SACC) Manual</u> (<a href="https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual">https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual</a>) issued by Public Works and Government Services Canada.

### 6.3.1 General Conditions

The Contractor must, upon the request of Canada, replace at its own expense including costs of returns and delivery of replacement Work as soon as possible any supplies that fail to conform or that deteriorates prior to the expiration date required by the Requirement.
- (ii) If full replacement is not available in a timeframe acceptable to Canada, then Canada may, in addition to and without prejudice to any other remedy available, choose from one of the following options for the quantity and Contract value of the Work affected:
  - (a) Full and immediate reimbursement;
  - (b) Equivalent full credit against future purchases under the Contract; or
  - (c) Partial replacement and partial reimbursement or partial credit

#### 6.4 Term of Contract

#### 6.6 **Payment**

#### 6.6.1 **Basis of Payment - Firm Unit Price(s)**

#### 6.8 Certifications and Additional Information

#### 6.8.1 Compliance

A. Unless specified otherwise, the continuous compliance with the certifications provided by the Contractor in its bid or precedent to contract award, and the ongoing cooperation in providing additional information are conditions of the Contract and failure to comply will constitute the Contractor in default. Certifications are subject to verification by Canada during the entire period of the Contract.

## 6.9 Packaging

- A. Packaging for the Work must clearly indicate on packing slips and on the outside of outer packages and cartons, as applicable, the following:
  - (i) On each package and carton:
    - (a) Contractor's Name;
    - (b) Manufacturer's Brand Name;
  - (ii) On each package, carton, vial, ampoule, bottle, and pre-filled syringe (if applicable) the following:
    - (a) Drug Identification Number (DIN) and NATO Stock Number (NSN) (if applicable);
    - (b) Global Trade Identification Number (GTIN) (if applicable);
    - (c) Lot Number; and
    - (d) Expiry Date.
  - (iii) Identify the carton(s) which contain the packing slip. If the Contractor will use the GTIN, then Bar codes on shipping package (i.e., shrink wrapped product), secondary and primary package, including variable data, must comply with GS1 standards and the Canadian Automated Identification of Vaccine Products process (if applicable);
  - (iv) The Contractor must identify partly packed carton(s) and box (es).
  - (v) Packaging is to be in accordance with good commercial standards to ensure safe arrival at destination. In addition to the Contract Requirement, the Contractor must ensure that all goods are properly labeled and packaged in compliance with the Canadian Food and Drug Regulations.
  - (vi) Over the period of the Contract, the Contractor may offer other packaging options consistent with emerging technology. Canada retains the right to refuse such offerings.

## 6.10 Labelling

A. The Contractor must ensure that the manufacturer's and specification numbers appear on each item, either printed on the container or on an adhesive label of highest commercial standard affixed to the container.

## 6.11 Maintenance of Temperature Control During Transportation

- A. Throughout the shipping process, the Work must remain in temperature controlled and monitored conditions ("Transport Conditions") in accordance with the recommended storage conditions described within the Work labelling or prescribing information, specifically: 15°C to 25°C.
- B. The Contractor must use a continuous electronic temperature-monitoring device in each shipment. The Contractor must also include a receiving notice specifying acceptance criteria in each shipment. If a continuous electronic temperature-monitoring device is not used, Canada may request a colour cold chain chemical indicator (heat and freeze) be used by the Contractor.
- C. If a continuous electronic temperature-monitoring device is used Canada will accept the Work on a conditional basis until a Certificate of Conformity is received. The Contractor must provide a Certificate of Conformity to the Contracting Authority within three (3) business days of the Contractor's receipt of the monitoring device or the device's data in the case of an electronic information transfer. Unless the monitoring device is disposable, Canada will return all electronic monitoring devices to the Contractor within 2 business days of receiving the Work.
- D. A written Certificate of Conformity must confirm that:
  - (i) the required Transport Conditions were maintained during transport;
  - (ii) the integrity and quality of the Work has not been affected by temperature excursions during transport; and
  - (iii) the expiry date of the Work as indicated on the drug product packaging is not impacted by temperature excursions during transport.
- E. The Contractor must maintain a record of the shipment and transport data when using an electronic monitoring device for the purpose of addressing any future enquiries from Canada. The Contractor must keep these records, at a minimum, until 12 months after the expiry date of the Work, as indicated on the Work packaging label or 12 months following the end of the period of the Contract, whichever is later.
- F. Failure of the Contractor to provide a Certificate of Conformity within this timeframe will entitle Canada to return the Work to the Contractor for full replacement at no additional cost to Canada.
- G. Acceptance by Canada of a shipment not meeting the Transport Conditions is not a waiver of Transport Conditions for future shipments experiencing similar Transport Conditions.
- H. During the evaluation of the Transport Conditions by the Contractor, Canada will ensure that the Work is maintained according to the storage recommendations stated in the labelling or prescribing information.

#### 6.12 Product Recall or Withdrawal

- A. In the event of a recall or a withdrawal of Work, the Contractor must notify the Contracting Authority and must collect and destroy the delivered, recalled, or withdrawn Work at their own cost.
- B. The Contractor must, upon the request of Canada, replace as soon as possible any recalled or withdrawn Work at their own cost.

- (iii) Partial replacement and partial immediate reimbursement or partial credit under the Contract.

## 6.13 Product Dating

A. All Work supplied must have a shelf life of no less than 40 months remaining upon arrival at DND Central Medical Equipment Depot (CMED).

## 6.14 Notice of Anticipated Shortage

A. The Contractor must notify the Contracting Authority when it becomes aware of a potential problem, delay, or event that may lead to a shortage of any of the orders. Such notice must include a description of the nature of the problem or delay or event, the anticipated impact on the Contract, the steps being taken by the Contractor to rectify the situation or to minimize the impact on this Contract, and the expected date by which the shortage will be fully corrected.

For the purpose of this clause "shortage" is defined as the inability to supply the Work in full.

## 6.15 Inability to Supply

- A. In the event that the Contractor is unable to supply the Work in accordance with the terms and conditions of the Contract, whether as the result of drug discontinuation or for any other reason, the Contractor will provide a substitute product acceptable to Canada at a price no greater than firm unit price specified in Annex B.
- B. If the Contractor is unable to provide a substitute product acceptable to Canada and if Canada is required to purchase the Work from an alternate source at a higher price, the Contractor must reimburse Canada for the difference between the price paid to the alternate source and the firm unit price specified in Annex B.
- C. Should Canada be required to purchase the Work from an alternate source, Canada reserves the right to adjust the final total estimated quantity in the Contract.

#### 6.16 Applicable Laws

A. The Contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario or as specified by the bidder in its bid, if applicable.

## 6.17 Priority of Documents

A. If there is a discrepancy between the wording of any documents that appear on the list, the wording of the document that first appears on the list has priority over the wording of any document that subsequently appears on the list:

#### 6.18 Defence Contract

- A. The Contract is a defence contract within the meaning of the <u>Defence Production Act</u>, R.S.C. 1985, c. D-1 (<u>http://laws-lois.justice.gc.ca/eng/acts/d-1/</u>), and must be governed accordingly.
- B. Title to the Work or to any materials, parts, work-in-process or finished work must belong to Canada free and clear of all claims, liens, attachments, charges or encumbrances. Canada is entitled, at any time, to remove, sell or dispose of the Work or any part of the Work in accordance with section 20 of the <u>Defence Production Act</u>.

#### 6.19 Excess Goods

A. The quantity of goods to be delivered by the Contractor is specified in the Contract. The Contractor remains liable for any shipment in excess of that quantity whether the excess quantity is shipped voluntarily or as a result of an error by the Contractor. Canada will not make any payment to the Contractor for goods shipped in excess of the specified quantity. Canada will not return the said goods to the Contractor unless the Contractor agrees to pay for all the costs related to the return, including but not limited to administrative, shipping and handling costs. Canada will have the right to deduct such costs from any invoice submitted by the Contractor.

One (1) of the following two (2) options will be inserted in the resulting contract, as applicable:

# Option 1: <u>A2000C</u> (2006-06-16) when the contract is to be with a Canadian-based supplier; or 6.20 Foreign Nationals (Canadian Contractor)

A. The Contractor must comply with Canadian immigration requirements applicable to foreign nationals entering Canada to work temporarily in fulfillment of the Contract. If the Contractor wishes to hire a foreign national to work in Canada to fulfill the Contract, the Contractor should immediately contact the nearest Service Canada regional office to enquire about Citizenship and Immigration Canada's requirements to issue a temporary work permit to a foreign national. The Contractor is responsible for all costs incurred as a result of non-compliance with immigration requirements.

The Contractor is responsible for all costs incurred as a result of noncompliance with immigration requirements.

#### 6.21 Insurance

A. The Contractor is responsible for deciding if insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any insurance acquired or maintained by the Contractor is at its own expense and for its own benefit and protection. It does not release the Contractor from or reduce its liability under the Contract.

## 6.22 Dispute Resolution

- A. The parties agree to maintain open and honest communication about the Work throughout and after the performance of the contract.
- B. The parties agree to consult and co-operate with each other in the furtherance of the contract and promptly notify the other party or parties and attempt to resolve problems or differences that may arise.
- C. If the parties cannot resolve a dispute through consultation and cooperation, the parties agree to consult a neutral third party offering alternative dispute resolution services to attempt to address the dispute.
- D. Options of alternative dispute resolution services can be found on Canada's Buy and Sell website under the heading "<u>Dispute Resolution</u>".

#### 6.23 Returns

A. In addition to and without prejudice to any other remedy available, for Work damaged during shipment from the Contractor, the Contractor must provide full credit or replacement or refund for all Work returned by Canada where the Contractor was contacted within 3 business days of delivery to and acceptance by Canada. Canada will return damaged Work to the address specified below. The Contractor is responsible for shipping costs.

## 6.24 Taxes - Foreign-based Contractor

- A. Unless specified otherwise in the Contract, the price includes no amount for any federal excise tax, state or local sales or use tax, or any other tax of a similar nature, or any Canadian tax whatsoever. The price, however, includes all other taxes. If the Work is normally subject to federal excise tax, Canada will, upon request, provide the Contractor a certificate of exemption from such federal excise tax in the form prescribed by the federal regulations.
- B. Canada will provide the Contractor evidence of export that may be requested by the tax authorities. If, as a result of Canada's failure to do so, the Contractor has to pay federal excise tax, Canada will reimburse the Contractor if the Contractor takes such steps as Canada may require to recover any

payment made by the Contractor. The Contractor must refund to Canada any amount so recovered.

## 6.25 Shipping Instruction (DND) - Delivered at Place (DAP) Incoterm 2010

- A. Goods must be consigned to the destination specified in the Contract and delivered:
  - Delivered at Place (DAP) Petawawa, Ontario, Incoterms 2010 for shipments from a commercial contractor.
  - (ii) The Contractor is responsible for export clearance, delivery charges, administration, costs and risks of transport. Canada is responsible for all import clearance, including the payment of applicable duties and taxes.

## 6.26 Transportation Costs

A. The Contractor must ship the goods prepaid including all delivery charges to Petawawa, Ontario. Prepaid transportation costs must be shown as a separate item on the invoice, supported by a certified copy of the prepaid transportation bill of lading.


#### 6.27 Canadian Customs Documentation

#### A. General

- 1. The Contractor must provide two (2) copies of the Canada Customs Invoice (CCI) or two (2) copies of the commercial invoice marked "For Customs Purposes Only".
- 2. Shipments from the United States and Mexico that are of American, Mexican or Canadian origin, as defined by the *Canada-United States-Mexico Agreement* (CUSMA):
  - a) For goods valued at more than USD\$1,000, the Contractor must provide a certification of origin of the goods that demonstrate that the good is originating. This may be provided on the commercial invoice or any other document and does not need to follow a prescribed format, but must:
    - (i) Describe the originating good in sufficient detail to enable its identification;
    - (ii) Meet the requirements as set out in the <u>Uniform Regulations for Rules of Origin</u>; and
    - (iii) Contain a set of minimum data elements as described in Annex 5-A (<u>Chapter 5</u> of CUSMA) that indicate that the good is both originating and meets the requirements of Chapter 5.
  - b) For goods valued at USD\$1,000 or less, the proof must be a statement on the invoice certifying that the good qualifies as an originating good.

In either case, an original signature and a reference to the contract number must be included in the document. For contracts valued at C\$250,000 or more, the certification of origin will not be required. If applicable, the exchange rate to be used to determine the value of goods in USD is the exchange rate on the Direct Shipment Date, which is the date the shipment starts its direct journey to the Buyer.

- 3. For shipments from Israel that are Israeli in origin, as defined by the Canada-Israel Free Trade Agreement (CIFTA), the Contractor must provide the certification of origin of the goods. This proof must be in the form of a CIFTA Certificate of Origin for goods valued at more than C\$1,600, or for goods valued at C\$1,600 or less, a statement on the invoice certifying that the good qualifies as an originating good. In either case, an original signature and a reference to the contract number must be included in the document. For contracts valued at C\$250,000 or more, the proof of origin will not be required.
- The Contractor must not employ commercial customs brokers to custom clear the goods provided under the Contract, unless authorized by the Canadian Material Support Group / Customs, at National Defence Headquarters, telephone: 1-855-210-5149, facsimile: 1-800-306-1811 or 613-971-7333.

## B. <u>Completion of Documents</u>

The CCI or commercial invoice must include the following information:

- a) complete description of the goods being shipped, including the applicable United States "Schedule B" codes or United States Harmonized Tariff Schedule codes;
- b) value and terms of sale for each item (e.g. sale, loan, warranty, Incoterms 2010), including value of repairs, warranty repairs or replacement costs;
- c) the Contract number and financial codes (use Field 3 on the CCI form);
- d) country of origin of goods; and
- e) one of the following:
  - (i) when a CUSMA Certification of Origin/CIFTA Certificate of Origin has been prepared, a statement in the "Description" field of the CCI or commercial invoice confirming that the CUSMA Certification of Origin/CIFTA Certificate of Origin has been completed and is attached to the CCI or commercial invoice; or
  - (ii) when a CUSMA Certification of Origin/CIFTA Certificate of Origin was not required, a statement in the "Description" field of the CCI or commercial invoice certifying that the good qualifies as an originating good.

## C. Distribution of Documents

- The Contractor must attach one (1) copy of the CCI or one (1) copy of the commercial invoice, as applicable, to shipping container No. 1 of all shipments using a waterproof envelope marked "Canada Customs Documentation".
- 2. The second copy of each of the above-mentioned forms must be attached to the shipping documents.


