PART 1 - GENERAL INFORMATION

1.1 Introduction

The bid solicitation is divided into seven parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation;
- Part 3 Bid Preparation Instructions: provides Bidders with instructions on how to prepare their bid;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria that must be addressed in the bid, and the basis of selection;
- Part 5 Certifications and Additional Information: includes the certifications and additional information to be provided;
- Part 6 Security Requirements: includes specific requirements that must be addressed by Bidders; and
- Part 7 Resulting Contract Clauses: includes the clauses and conditions that will apply to any resulting contract.

The Annexes include the Statement of Work, the Basis of Payment, the Security Requirements Checklist, the Task Authorization Form and any other annexes.

1.2 Summary

The Canadian Science Centre for Human and Animal Health (CSCHAH), the JC Wilt Infectious Diseases Research Centre (JCWIDRC) and the Medical Countermeasures (MCM) facility have a requirement for the services of certified and experienced personnel for the provision of autoclave maintenance and repair service on a scheduled and as and when requested basis.

The Scope of Work detailed herein includes, but shall not be limited to, the provision, by the Contractor, of all labour, supervision, material and equipment necessary to complete the work and provide the services as detailed herein.

There are security requirements associated with this requirement. For additional information, consult Part 6 - Security, Financial and Other Requirements, and Part 7 - Resulting Contract Clauses. For more information on personnel and organization security screening or security clauses, Bidders should refer to the [Contract Security Program](http://www.tpsgc-pwgsc.gc.ca/esc-src/introduction-eng.html) of Public Works and Government Services Canada (<http://www.tpsgc-pwgsc.gc.ca/esc-src/introduction-eng.html>) website.

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.



PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2022-03-29) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2.2 Submission of Bids

Bids must be submitted only to jeremy.mallon@hc-sc.gc.ca at the time and place indicated on the front page of the bid solicitation.

Due to the nature of the bid solicitation, bids transmitted by e-post or facsimile will not be accepted.

2.3 Former Public Servant

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. In order to comply with Treasury Board policies and directives on contracts awarded to FPSs, bidders must provide the information required below before contract award. If the answer to the questions and, as applicable the information required have not been received by the time the evaluation of bids is completed, Canada will inform the Bidder of a time frame within which to provide the information. Failure to comply with Canada's request and meet the requirement within the prescribed time frame will render the bid non-responsive.

Definitions

For the purposes of this clause, "*former public servant*" is any former member of a department as defined in the [Financial Administration Act](#), R.S., 1985, c. F-11, a former member of the Canadian Armed Forces or a former member of the Royal Canadian Mounted Police. A former public servant may be:

- a. an individual;
- b. an individual who has incorporated;
- c. a partnership made of former public servants; or
- d. a sole proprietorship or entity where the affected individual has a controlling or major interest in the entity.

"*lump sum payment period*" means the period measured in weeks of salary, for which payment has been made to facilitate the transition to retirement or to other employment as a result of the implementation of various programs to reduce the size of the Public Service. The lump sum payment period does not include the period of severance pay, which is measured in a like manner.

"*pension*" means a pension or annual allowance paid under the [Public Service Superannuation Act](#) (PSSA), R.S., 1985, c. P-36, and any increases paid pursuant to the [Supplementary Retirement Benefits Act](#), R.S., 1985, c. S-24 as it affects the PSSA. It does not include pensions payable pursuant to the [Canadian Forces Superannuation Act](#), R.S., 1985, c. C-17, the [Defence Services Pension Continuation Act](#), 1970, c. D-3, the [Royal Canadian Mounted Police Pension Continuation Act](#), 1970, c. R-10, and the [Royal Canadian Mounted Police Superannuation Act](#), R.S., 1985, c. R-11, the [Members of Parliament Retiring Allowances Act](#), R.S. 1985, c. M-5, and that portion of pension payable to the [Canada Pension Plan Act](#), R.S., 1985, c. C-8.



Former Public Servant in Receipt of a Pension

As per the above definitions, is the Bidder a FPS in receipt of a pension? **Yes () No ()**

If so, the Bidder must provide the following information, for all FPSs in receipt of a pension, as applicable:

- a. name of former public servant;
- b. date of termination of employment or retirement from the Public Service.

By providing this information, Bidders agree that the successful Bidder's status, with respect to being a former public servant in receipt of a pension, will be reported on departmental websites as part of the published proactive disclosure reports in accordance with [Contracting Policy Notice: 2019-01](#) and the [Guidelines on the Proactive Disclosure of Contracts](#).

Work Force Adjustment Directive

Is the Bidder a FPS who received a lump sum payment pursuant to the terms of the Work Force Adjustment Directive? **Yes () No ()**

If so, the Bidder must provide the following information:

- a. name of former public servant;
- b. conditions of the lump sum payment incentive;
- c. date of termination of employment;
- d. amount of lump sum payment;
- e. rate of pay on which lump sum payment is based;
- f. period of lump sum payment including start date, end date and number of weeks;
- g. number and amount (professional fees) of other contracts subject to the restrictions of a work force adjustment program.

2.4 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 5 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.5 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Manitoba.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.6 Improvement of Requirement During Solicitation Period

Should bidders consider that the specifications or Statement of Work contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to



the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least 10 days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

2.7 Optional Site Visit

It is recommended that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held at 1015 Arlington St and 745 Logan Avenue on December 15, 2022. The site visit will begin at 10:00am CST, at 1015 Arlington St in the lobby.

Bidders must communicate with the Contracting Authority no later than December 15 at 9:00am CST to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders who do not confirm attendance, provide the name(s) of the person(s) who will attend, or who do not complete and submit the above certification as required will not be allowed access to the site. Bidders will be requested to sign an attendance sheet. No alternative appointment will be given to bidders who do not attend or do not send a representative. Bidders who do not participate in the visit will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

2.8 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.
- (b) Canada encourages suppliers to first bring their concerns to the attention of the Contracting Authority. Canada's [Buy and Sell](#) website, under the heading "[Bid Challenge and Recourse Mechanisms](#)" contains information on potential complaint bodies such as:
 - Office of the Procurement Ombudsman (OPO)
 - Canadian International Trade Tribunal (CITT)
- (c) Suppliers should note that there are **strict deadlines** for filing complaints, and the time periods vary depending on the complaint body in question. Suppliers should therefore act quickly when they want to challenge any aspect of the procurement process.



PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Due to the nature of the bid solicitation, bids transmitted by epost Connect service and by facsimile will not be accepted.

Canada requests that bidders provide their bid in separately bound sections as follows:

Section I: Technical Bid electronic copy by email

Section II: Financial Bid electronic copy by email

Section III: Certifications electronic copy by email

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- (a) use a numbering system that corresponds to the bid solicitation.

Section I: Technical Bid

In their technical bid, Bidders should demonstrate their understanding of the requirements contained in the bid solicitation and explain how they will meet these requirements. Bidders should demonstrate their capability in a thorough, concise and clear manner for carrying out the work.

The technical bid should address clearly and in sufficient depth the points that are subject to the evaluation criteria against which the bid will be evaluated. Simply repeating the statement contained in the bid solicitation is not sufficient. In order to facilitate the evaluation of the bid, Canada requests that Bidders address and present topics in the order of the evaluation criteria under the same headings. To avoid duplication, Bidders may refer to different sections of their bids by identifying the specific paragraph and page number where the subject topic has already been addressed.

Section II: Financial Bid

Bidders must submit their financial bid in accordance with the Basis of Payment in Annex "B".

Section III: Certifications

Bidders must submit the certifications and additional information required under Part 5.



PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Technical Evaluation

4.1.1.1. Mandatory Technical Criteria

The bid must meet the mandatory criteria set out below. The Bidder must provide the necessary documentation to support compliance. Bids which fail to meet the mandatory criteria will be declared non-responsive. Mandatory criteria are evaluated on a simple pass or fail basis. This will be evaluated as either “Yes” or a “No.”

4.2 Basis of Selection - Mandatory Technical Criteria

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.



PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue, whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

Bidders must submit the following duly completed certifications as part of their bid.

5.1.1 Integrity Provisions - Declaration of Convicted Offences

In accordance with the Integrity Provisions of the Standard Instructions, all bidders must provide with their bid, **if applicable**, the Integrity declaration form available on the [Forms for the Integrity Regime](http://www.tpsgc-pwgsc.gc.ca/ci-if/declaration-eng.html) website (<http://www.tpsgc-pwgsc.gc.ca/ci-if/declaration-eng.html>), to be given further consideration in the procurement process.

5.2 Certifications Precedent to Contract Award and Additional Information

The certifications and additional information listed below should be submitted with the bid but may be submitted afterwards. If any of these required certifications or additional information is not completed and submitted as requested, the Contracting Authority will inform the Bidder of a time frame within which to provide the information. Failure to provide the certifications or the additional information listed below within the time frame specified will render the bid non-responsive.

5.2.1 Integrity Provisions – Required Documentation

In accordance with the section titled Information to be provided when bidding, contracting or entering into a real property agreement of the [Ineligibility and Suspension Policy](http://www.tpsgc-pwgsc.gc.ca/ci-if/politique-policy-eng.html) (<http://www.tpsgc-pwgsc.gc.ca/ci-if/politique-policy-eng.html>), the Bidder must provide the required documentation, as applicable, to be given further consideration in the procurement process.



PART 6 - SECURITY AND INSURANCE REQUIREMENTS

6.1 Security Requirements

1. Prior to contract award, the following conditions must be met:
 - (a) the Bidder must hold a valid organization security clearance as indicated in Part 7 - Resulting Contract Clauses;
 - (b) the Bidder's proposed individuals requiring access to classified or protected information, assets or sensitive work sites must meet the security requirements as indicated in Part 7 - Resulting Contract Clauses;
 - (c) the Bidder must provide the name of all individuals who will require access to classified or protected information, assets or sensitive work sites;
2. Bidders are reminded to obtain the required security clearance promptly. Any delay in the award of a contract to allow the successful Bidder to obtain the required clearance will be at the entire discretion of the Contracting Authority.
3. For additional information on security requirements, Bidders should refer to the [Contract Security Program](http://www.tpsgc-pwgsc.gc.ca/esc-src/introduction-eng.html) of Public Works and Government Services Canada (<http://www.tpsgc-pwgsc.gc.ca/esc-src/introduction-eng.html>) website.

6.2 Insurance Requirements

The Contractor must comply with the insurance requirements specified in Annex C. The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.

The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.

The Contractor must forward to the Contracting Authority within ten (10) days after the date of award of the Contract, a Certificate of Insurance evidencing the insurance coverage and confirming that the insurance policy complying with the requirements is in force. For Canadian-based Contractors, coverage must be placed with an Insurer licensed to carry out business in Canada, however, for Foreign-based Contractors, coverage must be placed with an Insurer with an A.M. Best Rating no less than "A-". The Contractor must, if requested by the Contracting Authority, forward to Canada a certified true copy of all applicable insurance policies.



PART 7 - RESULTING CONTRACT CLAUSES

The following clauses and conditions apply to and form part of any contract resulting from the bid solicitation.

7.1 Statement of Work

The Contractor must perform the Work in accordance with the Statement of Work at Annex "A".

7.1.1 Task Authorization

The Work or a portion of the Work to be performed under the Contract will be on an "as and when requested basis" using a Task Authorization (TA). The Work described in the TA must be in accordance with the scope of the Contract.

7.1.1.1 Task Authorization Process

1. The Project Authority will provide the Contractor with a description of the task using the Task Authorization form specified in Annex E
2. The Task Authorization (TA) will contain the details of the activities to be performed, a description of the deliverables, and a schedule indicating completion dates for the major activities or submission dates for the deliverables. The TA will also include the applicable basis(bases) and methods of payment as specified in the Contract.
3. The Contractor must provide the Project Authority, within 2 calendar days of its receipt, the proposed total estimated cost for performing the task and a breakdown of that cost, established in accordance with the Basis of Payment specified in the Contract.
4. The Contractor must not commence work until a TA authorized by the Project Authority has been received by the Contractor. The Contractor acknowledges that any work performed before a TA has been received will be done at the Contractor's own risk.

7.1.1.2 Task Authorization Limit

The Project Authority may authorize individual task authorizations up to a limit of \$_____ (*insert at contract award*), Applicable Taxes included, inclusive of any revisions.

Any task authorization to be issued in excess of that limit must be authorized by the Contracting Authority before issuance.

7.1.1.3 Canada's Obligation - Portion of the Work - Task Authorizations

Canada's obligation with respect to the portion of the Work under the Contract that is performed through task authorizations is limited to the total amount of the actual tasks performed by the Contractor.

7.2 Standard Clauses and Conditions

All clauses and conditions identified in the Contract by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

7.2.1 General Conditions

[2010C](#) (2022-01-28) General Conditions – Services (Medium Complexity), apply to and form part of the Contract.



7.2.2 Supplemental Conditions

7.2.2.1 On-Site Maintenance

The Contractor must perform on-site maintenance and related services with respect to Canada-owned equipment and components located at the site(s) identified at Annex "A". The Work will be performed on an as-and-when requested basis in accordance with the Statement of Work at Annex "A".

7.3 Security Requirements

7.3.1 The following security requirements (SRCL and related clauses provided by the Contract Security Program) apply and form part of the Contract.

1. The Contractor personnel requiring access to SECRET information, assets or sensitive work site(s) must EACH hold a valid SECRET level Security Clearance granted or approved by Health Canada/Public Health Agency of Canada or the Canadian Industrial Security Directorate (CISD), Public Services and Procurement Canada (PSPC).
2. The Contractor MUST NOT remove any PROTECTED or CLASSIFIED information or assets from the identified work site(s), and the Contractor must ensure its personnel are made aware of and comply with this restriction.
3. Subcontracts which contain security requirements are NOT to be awarded without the prior written permission of Health Canada/PHAC.

7.4 Term of the Contract

7.4.1 Period of the Contract

The period of the Contract is from Contract Award to March 31, 2025 inclusive.

7.4.2 Option to Extend the Contract

The Contractor grants to Canada the irrevocable option to extend the term of the Contract by up to three (3) additional one (1) year period(s) under the same conditions. The Contractor agrees that, during the extended period of the Contract, it will be paid in accordance with the applicable provisions as set out in the Basis of Payment.

Canada may exercise this option at any time by sending a written notice to the Contractor before the expiry date of the Contract. The option may only be exercised by the Contracting Authority, and will be evidenced for administrative purposes only, through a contract amendment.

7.4.3 Optional Goods and/or Services

The Contractor grants to Canada the irrevocable option to acquire the goods, services or both described in the statement of work (Part G) of the Contract under the same conditions and at the prices and/or rates stated in the Contract. The option may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the option at any time before the expiry of the Contract by sending a written notice to the Contractor.

7.7.2.1 Limitation of Expenditure - Cumulative Total of all Task Authorizations

1. Canada's total liability to the Contractor under the Contract for all authorized Task Authorizations (TAs), inclusive of any revisions, must not exceed the sum of \$ _____. Customs duties are excluded and Applicable Taxes are extra.
2. No increase in the total liability of Canada will be authorized or paid to the Contractor unless an increase has been approved, in writing, by the Contracting Authority.
3. The Contractor must notify the Contracting Authority in writing as to the adequacy of this sum:
 - a. when it is 75 percent committed, or
 - b. four (4) months before the contract expiry date, or
 - c. as soon as the Contractor considers that the sum is inadequate for the completion of the Work required in all authorized TAs, inclusive of any revisions, whichever comes first.
4. If the notification is for inadequate contract funds, the Contractor must provide to the Contracting Authority, a written estimate for the additional funds required. Provision of such information by the Contractor does not increase Canada's liability.

7.7.3 Method of Payment

7.7.3.1 Scheduled Services - Monthly Payment

Canada will pay the Contractor on a monthly basis for work performed during the month covered by the invoice in accordance with the payment provisions of the Contract if:

7.12 Insurance Requirements

The Contractor must comply with the insurance requirements specified in Annex C. The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.



The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.

ANNEX "A" - STATEMENT OF WORK

1. Scope of Work

1.1. Title

Autoclave Maintenance and Repair

1.2. Objectives of the Requirement

The Canadian Science Centre for Human and Animal Health (CSCHAH), the JC Wilt Infectious Diseases Research Centre (JCWIDRC) and the Medical Countermeasures (MCM) facility have a requirement for the services of certified and experienced personnel for the provision of autoclave maintenance and repair service on a scheduled and as and when requested basis.

The Scope of Work detailed herein includes, but shall not be limited to, the provision, by the Contractor, of all labour, supervision, material and equipment necessary to complete the work and provide the services as detailed herein.

1.3. Background

Canada's National Microbiology Laboratory Branch (NMLB) is known around the world for its scientific excellence. The NMLB works with public health partners in Canada and abroad to prevent the spread of infectious diseases. The NMLB has multiple sites across Canada.

The Canadian Science Centre for Human and Animal Health (CSCHAH) is unique in both Canada and the world. CSCHAH is recognized as a leading-edge facility in an elite group of centres around the world equipped with laboratories ranging from biosafety level 2 to level 4 designed to accommodate the most basic to the most deadly infectious organisms. It is the first high-containment laboratory in the world where both animal and human disease research are conducted within the same facility.

The JC Wilt Infectious Diseases Research Centre (JCWIDRC) is one of few laboratories in North America to receive LEED® Canada Gold, the second highest status for leadership in Energy and Environmental Design. LEED® is a rating system that is recognized as the international mark of excellence for green building in over 132 countries. The JCWIDRC, which serves as a hub for HIV research and diagnostics in Canada.

The Medical Countermeasures (MCM) facility is a new addition to the NMLB group of sites. MCM will ensure that Canada has the needed capacity to support and respond to the on-going COVID-19 pandemic as well as future public health events. Following significant retrofitting, this location will be equipped with laboratories ranging from biosafety level 2 to 3 designed to focus on the research and development of vaccines, monoclonal antibodies and other potential therapeutics. As MCM is currently in the development stage, there are currently no autoclaves functioning at this location. As renovations are completed and program activities increase, autoclaves will be added to the resulting Contract.

1.4. Location of Work, Work Site and Delivery Point

The Work will be performed at the Canadian Science Centre for Human and Animal Health (CSCHAH) located at 1015 Arlington Street, the JC Wilt Infectious Diseases Research Centre (JWIDRC) located at 745 Logan Avenue, Winnipeg, and at the Medical Countermeasures (MCM) facility located at 435 Ellice Ave, Winnipeg, Manitoba, Canada.



2. Requirements

2.1. Tasks, Activities, Deliverables and Milestones

- 2.1.1. The Scope of Work detailed herein includes, but shall not be limited to the provision, by the Contractor, of all labour, supervision, material and equipment necessary to complete the work and provide the services as detailed herein.
- 2.1.2. The Contractor must complete routine inspections and emergency services, including but not limited to equipment maintenance, equipment calibrations, and all miscellaneous services and repairs (i.e. gasket changes, etc.).
- 2.1.3. The Contractor must provide repair service on an as and when requested basis where NMLB is the sole authority for the issuance of such a request.
- 2.1.4. The Contractor's Technicians are required to perform a minimum of four (4) preventative maintenance (PM) inspections per year for each autoclave at times negotiated between the Contractor and the Project Authority.
- 2.1.5. The Contractor's Technicians are required to perform a minimum of four (4) preventative maintenance (PM) inspections per year for each washer and dryer at times negotiated between the Contractor and the Project Authority.
- 2.1.6. At a minimum each preventative maintenance inspection performed by the Contractor's Technicians must be comprised of:

Autoclave

Quarterly PM

- Check battery back up system
- Check safety valve
- Check steam traps
- Clean steam and water strainers
- Blow out drain
- Complete inspection in accordance with Manufacturer's specifications

Annually

- Chamber cleaning
- Complete inspection in accordance with Manufacturer's specifications
- Change HEPA filters and other associated Filters

Washers / Dryers

Quarterly PM

- Complete inspection in accordance with Manufacturer's specifications

- 2.1.7. Following any preventative maintenance or repair work and prior to the use by the program staff, the Contractor's technician must perform a test run to ensure the equipment is running safely.
- 2.1.8. A factory-trained technician must complete the inspections performed by the Contractor.
- 2.1.9. The Contractor must thoroughly inspect all autoclaves, washers and dryers and replace parts as required. Following the inspections, the equipment must be left operating at the manufacture's specifications and calibration settings.
- 2.1.10. The Contractor must change HEPA filters annually and / or as required. NMLB will provide the HEPA filters.
- 2.1.11. The Contractor must not include the cost of parts in the price per inspection.
- 2.1.12. The Contractor must provide maintenance for a minimum of twelve (12) Powerware Prestige 600 UPS units. Service shall include, maintenance, repair or replacement of



- the autoclave UPS systems (i.e. check and replace batteries, repair defective units, etc.).
- 2.1.13. The Contractor must include call backs for equipment breakdown following inspections into the Contract pricing. If an adjustment is made or parts are replaced during an inspection to a piece of equipment and a problem occurs relating to the adjustment or part replacement within a seven (7) day period, NMLB will not compensate the Contractor for a return service call. The call back period will be seven (7) working days after the scheduled inspection has been signed off by the Project Authority or designate.
- 2.1.14. If an "as and when" requested repair is made to a piece of equipment and the same problem occurs within a seven (7) day period, NMLB will not compensate the Contractor for a return service call. The call back period will be seven (7) working days after the "as and when" requested repair has been signed off by the Project Authority or designate.
- 2.1.15. The Contractor's technicians must maintain a detailed service log for each piece of equipment. Hard copies of the service log will remain the property of NMLB and will not leave the facilities. The detailed service log must include:
- a) Equipment location, serial number and model
 - b) Date of service
 - c) All hours spent servicing that piece of equipment
 - d) Summary of service
 - e) Listing of all parts replaced / repaired
 - f) Work order number for each service date
 - g) Service technicians name
 - h) Technicians observations
 - i) Any events which may cause concern over the operations and reliability of the equipment
- 2.1.16. The Contractor must provide telephone support to Laboratory support staff between the hours of 0600 and 1800 local time weekdays, excluding holidays. The Contractor must ensure that technicians providing telephone support are trained on the equipment listed in Appendix 1. The technicians providing telephone support do not need to be located in Winnipeg.
- 2.1.17. The Contractor's technicians are required to access Containment Level 4 (CL4) to conduct emergency repairs. The Contractor's technicians must be medically cleared and suit trained prior to gaining approval to enter this space. Suit training will be provided by NMLB Program staff. An NMLB program escort must accompany the Contractor's technician into CL4 to perform the work.
- 2.1.18. The Contractor's technicians must provide coaching via radio or telephone in situations where the repair can be completed by NMLB Program staff with the assistance of the Contractor's technicians.
- 2.1.19. Drain boxes for CL4 will be certified safe by NMLB staff prior to any work commencing on these units.
- 2.1.20. The Contractor's technicians must read blueprints and specification documents to determine size, extent of project requirements, compliance with codes and safety regulations.
- 2.1.21. The Contractor must assemble, erect or install material and personnel handling devices, scaffolds, ropes, slings and hoists.
- 2.1.22. The Contractor will identify to the Project Authority any product defect or damage the Contractor may come across or cause in the performance of the work by way of written report. The report will describe the condition of all equipment, maintenance performed, and recommendations for remedial maintenance and upgrades.



- 2.1.23. The Contractor must obtain a work order number from the Project Authority prior to work commencing.
- 2.1.24. When the request for service occurs after normal business hours and/or on weekends, the Contractor is to contact the Project Authority on the first working day following the request to obtain a work order number.
- 2.1.25. Regular business hours are 0600 to 1800 hours, Monday through Friday inclusive, excluding holidays. Building operation is 365 days per year 24 hours per day.
- 2.1.26. The Contractor will use installation procedures and methods of product modification and reconstruction that match the existing facility specification, product specification and to the satisfaction of the Project Authority or designate.
- 2.1.27. Unless otherwise specified, the Contractor must comply with manufacturer's latest printed instructions for materials and installation methods.
- 2.1.28. Attend meetings on site when requested by the Project Authority.
- 2.1.29. Following completion of work the Contractor must prepare a written report detailing the work performed and readings taken. The Contractor must submit a copy of the report to the Project Authority within ten (10) working days of completing the work.
- 2.1.30. When requested by the Project Authority, the Contractor will submit a written plan of operation for approval to ensure all work is being performed in a safe manner and will not cause damage to property or equipment, nor impact on critical laboratory programs.
- 2.1.31. The Contractor technicians must instruct the Project Authority and NMLB program staff of any new operating procedures when installing or modifying new or existing equipment.
- 2.1.32. The Contractor must provide upon request:
 - a) Input into and / or participate in an electronic presentation (i.e. PowerPoint) in conjunction with the Safety and Environmental Services (SES) department within the NMLB.
 - b) Hands on training (created by the Contractor in consultation with NMLB SES personnel) on an "as and when" requested basis. Training shall be based on routine maintenance, cleaning and operations.
- 2.1.33. The Contractor must review and provide technical input into the Standard Operating Procedures (SOP) for Autoclave / Washer / Dryer maintenance and service as developed by NMLB. In the event that the SOP requires modification, the Contractor must provide additional technical input.

2.2. Response Times

- 2.2.1. **"Routine"** - non-urgent service call which is to be performed during regular working hours and on normal working days. The Contractor must respond to request for services within one (1) working day of being notified by the Project Authority.
- 2.2.2. **"Emergency or Urgent"** – Contractor availability is 24 hours a day, 365 days a year and is to respond via telephone within two (2) hours and if required, to proceed to the site within four (4) hours (or as mutually agreed upon during the initial telephone contact) fully equipped with all necessary tools and parts required to facilitate general maintenance repairs. The Contractor is to repair or protect the system and/or equipment from further damage. Once the system has been made safe, provide within one (1) working day, a detailed estimate of time to complete repairs and put the equipment in proper working order.
- 2.2.3. **Telephone Support** – support provided to Laboratory support staff requiring technical assistance between 0600 to 1800 Monday to Friday, excluding holidays. The Contractor must respond by telephone within two (2) working hours of receiving the call for assistance.



- 2.2.4. The Contractor must have a staffed office at all times during normal business hours and a demonstrated ability to receive and respond to emergency calls outside of normal business hours. An answering machine only is NOT acceptable.
- 2.2.5. The Contractor must provide telephone numbers for regular service calls and the contact names and telephone numbers for emergency calls. The Contractor is responsible for advising the Project Authority in writing any changes to after-hour personnel schedule changes (weekend / holiday coverage) with a minimum of seven (7) calendar days' notice.

2.3. Personnel

- 2.3.1. The Contractor must, throughout the term of the Contract provide a minimum of two (2) factory trained technicians, each with a minimum of one (1) year experience working on equipment technically comparable to the units identified in Appendix 1.
- 2.3.2. The Contractor's technicians must be certified in either Steris Autoclaves and/or Getinge Castle Autoclaves. The Contractor's technicians must be able to perform preventative maintenance and repair equipment from both Steris and Getinge Castle.
- 2.3.3. The Contractor's technicians must have at minimum Level "M" electrical certification.
- 2.3.4. The Contractor's technicians must have valid [Workplace Hazardous Materials Information System \(WHMIS\)](#) certification.
- 2.3.5. The Contractor may use labourers/assistants to assist technicians in the performance of their duties.
- 2.3.6. The Contractor's technicians may at any time during the Contract be required to produce a copy of their valid license / certificate.
- 2.3.7. The Contractor's technicians must be trained and certified before performing the following: Operation of Scissor Lifts, Scaffold Erection, Confined Space access and Fall Protection. Any required training and associated cost will be the Contractor's responsibility. Contractor technicians will be required to produce valid certifications upon request.

2.4. Drawings and Maintenance Manuals

- 2.4.1. The Contractor is to update equipment service manuals and/or equipment logs to reflect any changes and/or modifications to equipment for future repairs.

2.5. Materials

- 2.5.1. The Contractor's technicians must leave packing or delivery slips for materials or replacement parts, at the time of delivery, with the person or persons appointed by the Project Authority. All materials delivered to the facilities must be delivered to CSCHAH, JCWIDRC or MCM shipping and receiving depending on location of work.
- 2.5.2. The Contractor must deliver, store and maintain materials with manufacturer's seals and labels intact.
- 2.5.3. The Contractor must ensure that parts and materials are stored in accordance with manufacturer and supplier's instructions.
- 2.5.4. The Contractor must obtain Project Authority approval prior to storing materials on site. NMLB does not accept responsibility for materials or equipment stored on site.
- 2.5.5. The Contractor must identify to the Project Authority all pertinent data relative to the new piece of equipment when an equipment inventory numbering system exists.
- 2.5.6. The Contractor must use materials and replacement parts that match existing building standard and code requirements. Alternative materials must have prior approval of the Project Authority. Any changes are to be approved by the Project Authority.
- 2.5.7. The Contractor must use new materials that conform to, or exceed the minimum applicable standards of the [Canadian Standards Association \(CSA\)](#) and / or the [National Building Code of Canada](#).



- 2.5.8. Where there is no alternative to supplying equipment which is not CSA certified, the Contractor must obtain special approval from Provincial Department of Labour.
- 2.5.9. The Contractor must ensure that all materials used in the workplace are classified and labeled according to the [Workplace Hazardous Materials Information Systems \(WHMIS\)](#).
- 2.5.10. The Contractor must provide copies of the Material Safety Data Sheets (MSDS) for products used on the premises to the Project Authority.
- 2.5.11. The Contractor must not include parts required to maintain the equipment in the base Contract price. These include; door gaskets, ribbons, tapes, consumable items and filters. The spare parts stock provided must be adequate to replace all parts of the equipment that commonly fail. Inventory level and content must be kept at a level that down time will not be experienced by the NMLB program staff.
- 2.5.12. All parts necessary to maintain the equipment during and in between inspections will be supplied by the Contractor and may be stored on-site. Parts stored on-site will be stored in a secure location as determined by the Project Authority.
- 2.5.13. NMLB program staff may replace consumable parts between inspections. Used parts will be kept and turned over to the Contractor. Parts inventory will be replenished from the Contractor's warehouse at no initial cost to NMLB. All parts used by NMLB program staff will be paid for at the current published list price less a pre-determined discount. Cost will not exceed the Manufacturer's Suggested Retail Price.

2.6. Addition or Deletion of Equipment

- 2.6.1. In the event NMLB purchases new equipment, said equipment must be eligible for inclusion in the Contract following the warranty period if applicable. The new equipment is to be added at the quoted rate for the particular piece of equipment based on function. Any additional service charges for new equipment will be incorporated into the regular Contract billings on a no more than monthly basis commencing on the next contractual billing.
- 2.6.2. Should NMLB elect to remove equipment from service or to delete equipment from the service Contract, no penalty payment will be assessed. The Contractor will be notified in writing a minimum of 30 days in advance of the equipment being deleted from the Contract. The deletion of the equipment will be incorporated into the regular Contract billing on a no more than monthly basis commencing on the next contractual billing.

3. General Requirements

3.1. Specifications and Standards

- 3.1.1. The Contractor must pay all fees, obtain certificates and permits as required by code and provide the appropriate authorities having jurisdiction with all required information.
- 3.1.2. The Contractor must provide these certificates and permits for work to the Project Authority.
- 3.1.3. The Contractor must comply with all legislative and regulatory provisions whether federal, provincial or municipal applicable to the performance of the work. The Work is to be executed to meet or exceed the requirements of:



- a) Applicable Federal, Provincial and Municipal statutes, codes, regulations and acts;
- b) National Building Code of Canada;
- c) Canadian Biosafety Standards and Guidelines (CBSG);
- d) National Fire Protection Association Standards;
- e) National Fire Code of Canada;
- f) Canada Labour Code, Part II;
- g) Fire Commission of Canada #301 Standard for building Construction Operations 1981;
- h) Canadian Construction Safety Code, Provincial Government, Worker's Compensation Board and Municipal statutes and authorities;
- i) Materials and workmanship must conform to or exceed applicable standards of Canada Government Specifications Board (CGSB), Canadian Standards Association (CSA), and American Society for Testing Materials (ASTM) and reference organizations;
- j) Equipment or system manufacturer's specifications and calibration settings, instruction manuals and / or leaflets;
- k) Building specifications; and
- l) Workplace Hazardous Materials Information System (WHMIS)
- m) In the event of a conflict between any of the codes, regulations, acts or standards outlined in herein, the most stringent shall apply.

The latest editions of the above codes and standards are applicable throughout the period of the contract including any changes / revisions made during the contract period.

3.2. Existing Services

The Contractor must:

- 3.2.1. Protect and maintain existing active services.
- 3.2.2. Connect to existing services, with minimum disturbance to occupants and building operation.
- 3.2.3. Use existing services at no cost.
- 3.2.4. Advise the Project Authority of any equipment required to be shut down to execute service or repair. The Project Authority or his/her designate shall shut down the equipment, or, at the discretion of NMLB, be shut down by the Contractor under the supervision of the Project Authority.
- 3.2.5. Inform the Project Authority immediately of any code violation or required repairs which could pose a hazard to employees or building occupants.

3.3. Cleaning and Waste

The Contractor must:

- 3.3.1. Maintain work area free of accumulated waste and rubbish.
- 3.3.2. Remove and dispose of debris, used and obsolete material on a daily basis. Reuse and recycle wherever possible, onsite or offsite.
- 3.3.3. Remove grease, dust, dirt, stains, fingerprints and other foreign materials from sight-exposed interior and exterior finished surfaces affected by the Contract work.

3.4. Cutting, Fitting and Patching

The Contractor must cut, fit and patch where required for work under this Contract. Make good all disturbed surfaces to original condition.

3.5. Co-ordination and Protection

The Contractor must:



- 3.5.1. Execute work with minimum disturbance to occupants, public, and normal use of building.
- 3.5.2. Make arrangements with the Project Authority to facilitate execution of work.
- 3.5.3. Maintain access points and exits as work area could be occupied during execution of work.
- 3.5.4. When a shut down of a system is required for service, a mutually agreed upon schedule will be coordinated between the Project Authority and the Contractor. This will ensure that critical program schedules are not impacted. In some situations the Contractors schedule will be coordinated with the annual decontamination shut down of the laboratories. Every effort will be made by NMLB to allow the Contractor access to equipment being services to provide continuous Work. The equipment may not be in the same location within the building.
- 3.5.5. Maintain an as-built drawing showing the exact location of any changes made to the building, systems and equipment as per Section 2.4
- 3.5.6. Ensure Hot Works procedures are adhered to at all times.
- 3.5.7. Ensure all possible safety precautions are taken to protect employees or occupants during the course of the work.

3.6. Work Done by Other Means

This Contract does not create an exclusive right of the Contractor to perform the services specified herein. NMLB reserve the right to have any work done by other means.

3.7. Workmanship

- 3.7.1. All reconstruction and modification work must match or exceed the quality of fit and finish of the original or existing work. All workmanship is subject to inspection and approval by the Project Authority.
- 3.7.2. The Contractor shall replace all work unsatisfactory to the Project Authority without extra cost.

3.8. Technical, Operational and Organizational Environment

- 3.8.1. The Contractor's work will be coordinated by the Contractor's Representative under the direction of the NMLB staff responsible for the work.
- 3.8.2. The Contractor must perform the services within the identified Response Time as identified by the Project Authority.

3.9. Method and Source of Acceptance

- 3.9.1. Each requested task will be considered complete when the work order is completed to the satisfaction of the Project Authority and signed by the Project Authority.

3.10. Project Management Control Procedures

- 3.10.1. The Project Authority will monitor the progress of a project through the use of timesheets and work orders. The Project Authority will sign off on timesheets and work orders only when hours have been verified and the services have been completed to the satisfaction of the Project Authority.
- 3.10.2. When requested by the Project Authority, the Contractor must attend progress meetings on-site.
- 3.10.3. All labour hours submitted on invoices will be verified against the timesheets or work orders submitted to the Project Authority.



4. Additional Information

4.1. Canada's Obligations:

- i. A work order number will be provided by the Project Authority for each request for service.
- ii. Ensure that technicians have the required licenses/certificates to perform the work detailed in the SOW. The Project Authority may, at any time during the Contract request to inspect or obtain a copy of each tradesperson's license / certificate.
- iii. Provide access to manuals, specifications and blueprints.
- iv. Provide all Personal Protective Equipment (PPE) and tools required to work in containment level 3 and 4.
- v. Provide suit training to technicians for CL4 access.

4.2. Contractor's Obligations:

- i. All required licenses, certifications and permits must be kept current throughout the entire term of this contract.
- ii. The Contractor must, throughout the term of the Contract, maintain a minimum of two (2) qualified (as detailed in 2.3 Personnel), security cleared technicians.
- iii. The Contractor's Representative will ensure the scope of work is brought in on time, on budget and of an acceptable quality.
- iv. Provide the necessary material and equipment needed to carry out these activities.
- v. Unless otherwise specified, the Contractor must use its own equipment and software for the performance of this Statement of Work.
- vi. The Contractor must be prepared to work with NMLB staff to carry out verifications.
- vii. The Contractor must receive and respond to calls during normal business hours and to emergency calls outside regular hours.
- viii. The Contractor must not list, publicize or use for business promotion purposes, the address of the work of this Contract, the name of the facility, Agency or the Government of Canada.

4.3. Language of Work

The Work shall be performed in English.

5. Special Requirements

5.1. Immunization and Health Certificate of Contractor's Personnel

- 5.1.1. Immunization and a health assessment may be required depending on the work location in the building and level of risk. Risk assessment will be completed prior to any work of this nature being undertaken and the Contractor will be advised of any requirements, if required. As a minimum, the following shall apply:
 - 5.1.1.1. Basic requirements for entry into the facility and CL02: Current TD (tetanus) booster; i.e. within the past 10 years; Hepatitis B highly recommended. Costs associated with these requirements will be the responsibility of the Contractor and/or the Contractor's technician;
 - 5.1.1.2. For CL03 Entry – based on a “case by case” risk assessment, the following activities will be performed on site as required: Health history (Cat II medical with Occupational Health Nurse or Cat III medical with physician if deemed necessary). Costs associated with these requirements will be the responsibility of NMLB.
- 5.1.2. CL03 TB lab Only Mantoux TB skin test. Costs associated with this requirement will be the responsibility of NMLB.
- 5.1.3. When requested, proof of testing and/or immunization must be provided to the Project Authority.



5.2. Site Safety

- 5.2.1. The Contractor must comply with the Canadian Code for Construction safety, The Manitoba Workplace Safety and Health Act and the requirements of the Fire Commissioner of Canada relating to the safety of persons on the worksite or the protection of the property against loss or damage from any cause including fire.
- 5.2.2. All persons including Contractors, sub trades, suppliers, delivery services, etc. must wear Grade 1 or 2 CSA approved Safety Footwear and other safety equipment necessary when working in or moving through the facility. On occasion NMLB may have requirements above minimum safety requirements.
- 5.2.3. The Contractor and his/her employees must comply with Laboratory Bio-Safety procedures and protocol which will be reviewed during the NMLB orientation session on building policies.
- 5.2.4. NMLB reserves the right to review the Contractor's Occupational Health and Safety Program documentation as it relates to the work performed at or on behalf of the NMLB.

5.3. Site Security

- 5.3.1. Site security is the responsibility of the Contractor who must erect temporary site or dust enclosures to prevent dust or other contaminants from escaping into other areas; barricades or fencing to prevent unauthorized entry.
- 5.3.2. For all work carried out after regular building operational hours, the Manager, Security Operations will determine acceptable building security.

5.4. Facility Access

- 5.4.1. Only those employees whose names appear on the Contractors approval list will be allowed access to the site under this Contract.
- 5.4.2. The Contractor and their technicians must provide valid photo identification and register with NMLB Security on-site when entering and leaving the facility to obtain and return a facility access pass.
- 5.4.3. All keys and/or proximity cards entrusted to the Contractor and their technicians for the fulfillment of this Contract must be returned to the security desk before departure from the building at the end of each working day. All lost keys or cards must be immediately reported to the security desk or the Project Authority.
- 5.4.4. The Contractor's technicians shall be subject to questioning and search of tools and supplies in relation to security matters by designated security staff.

5.5. Building Policies

- 5.5.1. The Contractor and his/her technicians must follow building policies and regulations including fire evacuation procedures, laboratory protocol, security requirements, and any directive issued from time to time by the Project Authority.
- 5.5.2. All approved technicians of the Contractor must attend an orientation session on NMLB building policies. This session is paid for by NMLB and subsequent orientation sessions will be made available for any new employees of the Contractor during the duration of this Contract.
- 5.5.3. The NMLB facilities are LATEXGLOVE FREE. No latex gloves are permitted in the facilities.
- 5.5.4. NMLB will supply tools and Personal Protective Equipment (PPE) inside of the containment level 3 and 4 areas of the laboratory. These tools are the property of NMLB and will not be allowed to leave these areas. The Contractor shall contact the Project Authority if insufficient and/or specialty tools are not available within the containment area.



- 5.5.5. Provisions of tools and PPE by NMLB for work performed in containment areas are in accordance with building policies and applicable regulatory directives. Accordingly, no employee-employer relationship is to be implied or construed by this provision.
- 5.5.6. The Contractor must conserve energy and non-renewable resources with due regard for property protection, safety of workers and employees and override by-laws and regulations.
- 5.5.7. The Contractor must not list, publicize or use for business promotion purposes, the address of the work of this Contract, the name of the facility, Agency or the Government of Canada.
- 5.5.8. The Contractor must respect the Government of Canada's No Smoking policy on these premises.
- 5.5.9. The use of AM/FM radios and other similar devices will not be allowed in mechanical spaces, corridors and related areas.
- 5.5.10. All technicians must refrain from wearing / listening to any personal entertainment device, or any other device that might limit hearing and vision in all laboratory and mechanical spaces. This includes, but is not limited to iPods or MP3 players.
- 5.5.11. All technicians are prohibited from using personal or business related portable electronic devices to take photos/videos or personnel or government assets. This applies to all areas of the facility.
- 5.5.12. Wherever possible, the use of scented products is to be minimized. Contractor's technicians working on-site at the NMLB facilities are to be advised to limit the use of scented personal products (perfumes, aftershaves, etc.).
- 5.5.13. Due to the ongoing COVID-19 pandemic, on occasion, the NMLB may require the Contractor's technicians follow additional mandated health and safety measures prior to entering and while within Government of Canada buildings. These mandated practices will be communicated to the Contractor as they arise.

5.6. Laboratory Bio Safety Guidelines

- 5.6.1. The [Canadian Biosafety Standards and Guidelines \(CBSG\)](#) provide information regarding the controls and restrictions when working in containment laboratories. Chapter 4 – Operational Practice Requirements, in particular describes the operational practice requirements designed to mitigate risks.

5.7. Parking

- 5.7.1. There is no parking available at 745 Logan Avenue location and vehicle owners are required to find alternative parking off site of the JCWIDRC facility.
- 5.7.2. Parking availability at MCM will be communicated with the Contractor and their technicians as the development of the site progresses.
- 5.7.3. Parking will be made available at 1015 Arlington Street to the Contractor and their technicians. Only vehicles with proper signage, operated by the Contractor who is on-site for facility related business will be given parking. Contractors must park their vehicles on the gravel lot located at the North East corner of the parking lot. (If no spaces are available on the gravel lot, the vehicle owner will be required to find alternative parking offsite of the CSCHAH parking lot).
- 5.7.4. Each vehicle must be parked front end in first. Backing into the parking spot is not allowed in order to protect the electrical posts.
- 5.7.5. Contractor and their personnel must register their vehicle at the security reception desk. Failure to do so may result in the vehicle being towed.
- 5.7.6. There will be no parking in the fire lane, which is clearly marked with "No Parking" signs. Any vehicles parking in the fire lane will be subject to being towed at the owner's expense.
- 5.7.7. There will be no overnight parking or storage of a vehicle allowed.



- 5.7.8. CSCHAH does not take any responsibility for vehicles parked on the lot. Parking on the lot is at the owner's risk.
- 5.7.9. Unauthorized vehicles will be subject to tow at the owner's expense.

ANNEX "C" – INSURANCE REQUIREMENT

1. The Contractor must obtain Commercial General Liability Insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$2,000,000 per accident or occurrence and in the annual aggregate.
2. The Commercial General Liability policy must include the following:
 - a. Additional Insured: Canada is added as an additional insured, but only with respect to liability arising out of the Contractor's performance of the Contract. The interest of Canada should read as follows: Canada, as represented by Public Works and Government Services Canada.
 - b. Bodily Injury and Property Damage to third parties arising out of the operations of the Contractor.
 - c. Products and Completed Operations: Coverage for bodily injury or property damage arising out of goods or products manufactured, sold, handled, or distributed by the Contractor and/or arising out of operations that have been completed by the Contractor.
 - d. Personal Injury: While not limited to, the coverage must include Violation of Privacy, Libel and Slander, False Arrest, Detention or Imprisonment and Defamation of Character.
 - e. Cross Liability/Separation of Insureds: Without increasing the limit of liability, the policy must protect all insured parties to the full extent of coverage provided. Further, the policy must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.
 - f. Blanket Contractual Liability: The policy must, on a blanket basis or by specific reference to the Contract, extend to assumed liabilities with respect to contractual provisions.
 - g. Employees and, if applicable, Volunteers must be included as Additional Insured.
 - h. Employers' Liability (or confirmation that all employees are covered by Worker's compensation (WSIB) or similar program)
 - i. Broad Form Property Damage including Completed Operations: Expands the Property Damage coverage to include certain losses that would otherwise be excluded by the standard care, custody or control exclusion found in a standard policy.
 - j. Notice of Cancellation: The Contractor will provide the Contracting Authority thirty (30) days prior written notice of policy cancellation or any changes to the insurance policy.
 - k. If the policy is written on a claims-made basis, coverage must be in place for a period of at least 12 months after the completion or termination of the Contract.
 - l. Owners' or Contractors' Protective Liability: Covers the damages that the Contractor becomes legally obligated to pay arising out of the operations of a subcontractor.
 - m. Non-Owned Automobile Liability - Coverage for suits against the Contractor resulting from the use of hired or non-owned vehicles.



- n. All Risks Tenants Legal Liability - to protect the Contractor for liabilities arising out of its occupancy of leased premises.
- o. Sudden and Accidental Pollution Liability (minimum 120 hours): To protect the Contractor for liabilities arising from damages caused by accidental pollution incidents.
- p. Litigation Rights: Pursuant to subsection 5(d) of the [Department of Justice Act](#), S.C. 1993, c. J-2, s. 1, if a suit is instituted for or against Canada which the Insurer would, but for this clause, have the right to pursue or defend on behalf of Canada as an Additional Named Insured under the insurance policy, the Insurer must promptly contact the Attorney General of Canada to agree on the legal strategies by sending a letter, by registered mail or by courier, with an acknowledgement of receipt.

A copy of the letter must be sent to the Contracting Authority. Canada reserves the right to co-defend any action brought against Canada. All expenses incurred by Canada to co-defend such actions will be at Canada's expense. If Canada decides to co-defend any action brought against it, and Canada does not agree to a proposed settlement agreed to by the Contractor's insurer and the plaintiff(s) that would result in the settlement or dismissal of the action against Canada, then Canada will be responsible to the Contractor's insurer for any difference between the proposed settlement amount and the amount finally awarded or paid to the plaintiffs (inclusive of costs and interest) on behalf of Canada.
