QUESTIONS AND ANSWERS

Question 1: Does RCMP (D-Div) have a Smart Building strategy? If so could it share the strategy/architecture?

Answer 1: No, the RCMP does not have a Smart Building Strategy.

Question 2: Does the RCMP (D-Div) have a Digital Twin of each of its facilities/detachments?

Answer 2: No, the RCMP does not have a Digital Twin of each of its facilities/detachments.

Question 3: Does the RCMP (D-Div) have Internet of Things (IoT) sensors and central IoT hub connected to its Life Safety Systems?

Answer 3: No, the RCMP does not have IoT sensors and central IoT hub connected to its Life Safety Systems.

Question 4: Will copies of each locations fire alarm inspections reports and emergency lighting reports be added to the bid document information?

Question 5: Do you have previous reports you can send? This will provide device lists, which will help provide accurate pricing.

Question 6: The spreadsheet that you have referred me to indicates only the make and model for the fire alarm system. I am hoping to be provided a list of devices (Heat detectors, smoke detectors, audio/visual devices, pull stations, end of lines, relays, ect.) for each location. This will provide pertinent information so we can build our quotations. Please let me know if those device counts can be shared.

Question 7: Is there a set schedule on when Annuals are to be performed? With a large cost to this project being Travel costs, it would be beneficial to know what locations can share travel expenses to increase cost savings.

Answer 7: The schedule will be discussed with the bidder after contract award. The updated spreadsheet includes locations where shared travel expenses could be identified.

Question 8: Any chance to have last year's testing date for each location?

Answer 8: The updated spreadsheet includes the last testing date for each location.

Question 9: Any chance of getting location device counts? Ex. Location A has 56 Heats, 32 Smokes, 30 pull stations?

Answer 9: See the Inspection reports now posted to Canada Buys website.

Question 10: Would it be possible to plan an inspection trip as we go? Or it might be each one separate and not always hit the multiple locations at the time? I'm trying to understand how to quote. Each one is a separate trip, or I can make multiple locations at the time.

Answer 10: Inspections dates /schedule can be arranged to share travel as much as possible. This is encouraged. The majority of our buildings are staffed 5 days a week (Monday – Friday) and we do our best to accommodate these inspections.

Question 11: Will any previous Fire Alarm or Emergency Light reports for the locations be made available? They contain the location of all of the associated devices to the Fire Alarm panel, and are necessary to ensure a complete inspection, and to also assist with the pricing quotation.

Answer 11: See the Inspection reports now posted to Canada Buys website.

Question 12: There are also several locations marked as 'new addition, initial inspection required'. Just a comment, this makes it challenging to determine pricing for these locations, as the Main Panel is TBD.



Question 13: For 2023 inspections, is there a timeframe for when they would be most likely to occur, for example Summer months?

Answer 13: Expectation is that inspections for 2023 are completed in 2023. In past years we've done fly-in communities in the summer and then schedule drive-in communities between spring and fall.

Question 14: Are there any challenges to be aware of for travel, accommodation, and access to the more remote Northern locations, and patrol cabins that can be provided?

Answer 14: **Patrol Cabins**: Patrol Cabins are not staffed full time and require extra planning to ensure we have staff on-site during inspection. It is best to complete these inspections during summer months (July & August). If possible the RCMP will provide a flight from Thompson to all Patrol Cabins, but please note flights on the RCMP aircraft are not guaranteed. **Accommodations**: Accommodations are vendor responsibility. In select remote communities the RCMP may be able to offer accommodations if we have a vacant living quarters, however vendor should have their own plan in place if this is not possible. **Travel**: Some of our Remote communities are only accessible by aircraft, boat, or winter road. We suggest when you create your inspection schedule you plan to visit remote communities in the summer months by air travel/boat. In communities where a boat is required the RCMP will help with make those plans.



Question 15: We currently have a tech who is in Canada on a work visa working towards his permanent residency. Do you know if he would be eligible to work on sites if he passes the other security clearances?

Answer 15: In order to obtain FA2 security clearance if born outside Canada and does not have permanent resident status or Canadian citizenship we will require:

- Copy of government issued document proving their immigration status in Canada (i.e. work permit)
- Copy of Driver's License or other government issued identification containing name, date of birth and photo.
