**AMENDMENT 002 is hereby issued to amend the RFP with the following item:**

Respond to Questions 1-3;

**Q1:** Please confirm that each individual armrest pad's inward adjustment must move 2" laterally while in the parallel position, independent of the arm bracket adjustment itself, while maintaining a 360 degree rotation capability.

**A1:** Yes, the armrest pads need to be able to move laterally inward while in the parallel position, independent of the arm bracket itself, but the rotation capability does not have to be the full 360 degrees. As specified in the chair builder, the pivot adjustment is specified as a min. of 20 degrees inward and a min. of 10 degrees outward.

**Q2:** Please confirm for the A2 smaller chair that it requires a seat pan of 18.5" wide x 17" deep

**A2:** The seat pan dimensions are as specified in the chair builder A2. The width should be of a minimum of 17.7in and the depth should be adjustable with a min. of 50 mm (2.0 in.) adjustment within the range of 426 mm (16.75 in.) to 502 mm (19.75 in.).

**Q3:** Please confirm that both chairs must be from the same series from the same manufacturer

**A3:** The chairs do not need to be from the same series or manufacturer. The requirement is that each chair (A1 and A2) must meet the requirements of their respective chair builder.
