Question 1	At section R4, it is stated that the bidder should present two project summaries that they have experience in disposal of explosives packaging. Would projects related to hazardous materials will be acceptable for Transport Canada?
Answer 1	<i>No, this project is specific to explosives packaging.</i>

THIS SOLICITATION IS HEREBY AMENDED AS FOLLOWS:

- 1.1 DELETE from, 4.1.1. Mandatory Technical Criteria M2 in its entirety and REPLACE with the following.

M2	<p>The Bidder <u>must</u> demonstrate using project summaries that the proposed team has a minimum ten years of experience (within the period from January 2005 to date of Bid Closing) in the following:</p> <ul style="list-style-type: none"> • Experience in conducting surveys; • Experience interpreting waste management regulations in Canada (municipal, provincial, or federal); <p>More than one team member may be proposed with expertise in distinct experience items as long as there is at least one team member with five or more years of experience for each experience item.</p> <p>The Bidder must state which experience item is being exemplified by each project summary.</p> <p>*The month(s) of experience listed for a project or experience whose timeframe overlaps that of another referenced project or for a specific experience will only be counted once, however projects can count for both experience items above simultaneously.</p> <p>For example: Project 1 timeframe is July 2015 to December 2015 and applies to both experience items; Project 2 timeframe is October 2015 to January 2016 and only applies to the first experience item; the total months of experience for these two project references is seven (7) for the first experience item and four (4) for the second item.</p>
