### (B) QUESTIONS AND ANSWERS

Question 8: In Solicitation Amendment 1, question & answer 7, it indicates that only the Team ID form and cvs are the technical response requirements. However, it is understood that responses to all of M1 are required. Is this correct?

Answer 8: \*Correction\* this response corrects published question & answer #7 in Solicitation Amendment #1:

- a. Proponents proposals must include a response to each section of Mandatory Requirement 1 (M1).
- b. Proponents are requested to use the Team Identification Form in Appendix B when responding to M1. It is not mandatory to use Appendix B.
- c. In response to M1 Proponents may submit résumés/CVs, however it is not mandatory.
- d. Refer to SRE 1 Submission Requirements, which identifies all documents that must be included in proposals.

Question 9: There is no maximum page limitation noted. Please advise maximum page limitation for this proposal.

**Answer 9:** There is no maximum page limitation. Refer to Change 3 in this solicitation amendment.

Question 10: We believe that 1.2.1 refers to project Understanding and Approach that proponent should describe here, no other item in APPENDIX F SUBMISSION REQUIREMENTS AND EVALUATION (SRE) requests this information. Please confirm our understanding.

**Answer 10:** Refer to Change 4 in this solicitation amendment.

Question 11: We believe that 3.1.4 refers to personnel experience and this is where we should present personnel and their experience. Can we include sub-consultant personnel? Is an organisational chart required?
