This amendment 001 is raised to:

Response(s) (R) to Question(s) (Q):

Q1.

When calculating results that need to be representative $\pm 8.0\%$ (based on a 95% CI), we assume that any business or resident that completes the survey counts toward the estimate regardless if they own any of the machinery identified in question 8 of the survey? That is, the number of surveys required to reach the threshold includes those who may or may not own any equipment.

R1.

- Yes. Any business or resident that completes the survey should count towards the estimate regardless of whether they own any of the machines identified in question 8.
- It is important to note that the error margin should be calculated for each survey type (business and household) and each province and territory.

Q2.

Do all government organizations qualify to participate in the survey of businesses and organizations, or are any types excluded from the study?

R2.

- Branches of the military are excluded from the survey.
- Government organizations that qualify to participate in the survey should be organizations that are likely to own and operate the equipment including, but not limited to, municipalities and organizations managing parks.
