**Question 1:**

All the Hook & Loop Tapes called up are listed as D-80-001-153/SF-001, Type II (1" Adhesive backed), since all the tapes are sewn down, there is no need for the adhesive, we will deviate to Plain Backed and most likely deviate to a US Mil-Spec A-A-55126 because it is more readily available for small quantities. Will DND accept these deviations?

**Question 2:**

The thread listed on the drawings is much too heavy for the materials being sewn. The fabric is a light nylon taffeta, and the drawings call for Thread #25 (TEX 135) used for sewing. We will use a thread more suitable for the application. Thread #36 (TEX 90) and Thread #50 (TEX 60) for the bartacks, and this will not take from the performance of the units. Will DND accept these deviations?
