Question 1. Extension Required until Jan 13.

Answer 1. We can extend to 9 January. We are unable to extend any further due to concerns about meeting 31 March delivery and install date.

Question 2. Please provide drawing detailing where the work surfaces and overheads are to go

Answer 2. Please see Amendment 1.

Question 3. CAT 1B item #10 30" x 30" work surfaces - the workstations do not have room for them. We will float them on drawing and have no hardware or supports for them.

Answer 3. Please see Amendment 2 for part of the answer. Those 30" x 30" work surfaces are in a 90" x 90" workspace.

Question 4. Item #8 - 2 extra overheads that we don't know where they go.

Answer 4. There are only 2 individual overhead cabinets in area 4.

Question 5. NON SA #3 23" d x 41" work surface cannot be supported where we believe it to be located. We recommend 18" x 42" and will price our 24" x 42" standard product.

Answer 5. Acceptable

Question 6. Please provide a panel matrix showing the panel heights desired.

Answer 6. All base panels are 34 in height, middle panel 16 and top panel 16 – except the 7 panels that are work surface privacy which have a base of 34" and work surface privacy panel 8"
