QUESTIONS AND ANSWERS:

Question 6	<p>Can DND confirm if the following is acceptable :</p> <p>End customer would accept that all wireless communications be transferred via Ethernet and on their internal network to their virtual server. We do not provide a GSM based solutions for critical temperature monitoring. Each of the locations would need to be on the end users network for our system to be feasible.</p> <p>End user will need to provide the virtual server, Windows Server 2019 or 2022. An IP address for each wireless access point. Each site would have to be networked to the VM server.</p>
Answer 6	<p>As per the RFP (Sub-section 2.1.1.2), the Environmental Monitoring System must have receivers-gateways fitted with Global System for Mobile communications (GSM router). Therefore, we will not consider any solution that lacks GSM as per 2.1.1.2:</p> <p>2.1.1.2 Receivers-gateways fitted with Global System for Mobile communications (GSM) router. The total quantity of receivers-gateways must be determined by the Contractor based on the technology submitted and the layout of the refrigerators and freezers per location (see APPENDIX 3 TO ANNEX "A"- LAYOUT OF REFRIGERATORS AND FREEZERS PER LOCATION). The Contractor must indicate the number of receiver-gateways required for each location.</p>
