A. Questions and Answers

Q1. Has a project budget been established?

A1. A project budget has not been established.

Q2. Please provide the anticipated scope of civil work.

A2. Civil work is a minor component of the project, it will include the design of concrete accessibility features and other features at the consultant's discretion.

Q3. Per Section 3 – Anticipated Milestones, the field inspection and systems assessment should be completed by February 10, 2023. As per Section 7.1.1, access to the building must be requested at least 12 business days in advance. There doesn't appear to be sufficient time to give the notice required. Please confirm when PCA anticipates they will award the project, and when access to the site can be provided to achieve the February 10, 2023, milestone.

A3. Given the short turnaround on these milestones, advance notice is only required 4 business days prior to accessing the building. Project award will be completed as soon as possible once the RFP closes.

Q4. Per Section 3 – Anticipated Milestones, five (5) layout options will be submitted to PCA is on February 24, 2023, with PCA's review completed by March 3, 2023. As per Section 4.2.1, we are to provide a Project Schedule allowing 10 business days for PCA's review. Please confirm that PCA approves a one-week review period for this Project Schedule.

A4. PCA will be reviewing all submittals within a 1 week period to help ensure the project stays on track.
