The Design Upgrade amount is used at the discretion of the Project Authority (PA) prior to the manufacturing/ordering of the products , the PA will provide the Contractor with a written notice of Canada's Design Upgrade choices for each of the product(s) to be upgraded. The Contracting Authority will issue an amendment to the contract with the Design Upgrades and pricing.

Design Upgrade: is the process of replacing a product with a more innovative or enhanced version of the same product.
NSA:
NSA products can be incorporated in the RFB and must not exceed 30% of the firm quantity by category. NSA items must be added to the category that is most closely related and must be generic.


ANNEX C FLOOR PLAN(S)




