## **Amendment 002**

This amendment is raised to:

- A. Answer questions from bidders.

### **A. Questions and Answers**

**Q5.** Would Parks Canada consider a one-week extension to the proposal deadline for 5P468-22-0215/A - Washroom Building Design - Jasper National Park?

**A5.** No. Due to the already tight timeline, an extension will not be considered.

**Q6.** We understand that having recent experience is important, however from our perspective, also having projects that have stood the test of time is equally important. This is particularly true when considering building envelope and heritage conservation aspects. Would Parks Canada allow one of the project examples to be completed within the last 12 years so we can also be evaluated on the quality and longevity of our work?

**A6.** No. The two projects undertaken must be within the last 6 years.

**Q7.** The checklist on page 26 includes 2 items relating to integrity provisions. We cannot find any specific form or documentation which can be provided, even after following the links and the references within the RFP. Would it be sufficient to include a text declaration of "nothing to declare" under a heading of "Declaration of Convicted Offences"?
