A5 There is no application form that is to be used to submit a proposal to Veterans Affairs Canada in response to this Request for Proposal. Please note that a Request for Proposal (RFP) is not for funding a project with Veterans Affairs Canada. The intent of this RFP is to issue a contract to a supplier that can provide all of the services identified in Annex A – Statement of Work.

The instructions for submitting a proposal in response to a Request for Proposal are listed in Part 3 of the Solicitation. The Bidder's Technical proposal must demonstrate how the Bidder meets the mandatory and point rated technical requirements identified in Annex "D" Evaluation Criteria. The Bidder's Financial proposal (Annex B) must demonstrate the costs required to perform the entire scope of work of the Statement of Work.
