

For users, can you clarify the unlimited amount of users, as this is EMS system is to meet
Food and Drug Administration's (FDA's) part 11 of Title 21 of the Code of Federal Regulations. Can user logins be shared for certain groups of users?
User logins will be individual for the vast majority of sites, however it is possible that occasionally certain user logins would be for positions and shared amongst several personnel (ex: duty personnel)
How many dedicated/unique user logins are required in total?
An unlimited number of dedicated/ unique user logins are required, as per 2.1.2.1 of Appendix 1 to Annex A.
ANNEX A - STATEMENT OF REQUIREMENT For 2.2.2.3 One (1) Offsite Calibration of Probes per year, up to 3 years, is a rotational calibration of probes acceptable?
Yes, a rotational calibration of probes is acceptable, provided all probes are calibrated yearly if options for calibration are exercised, as per 2.2.2.3 of Annex A.
ANNEX A - STATEMENT OF REQUIREMENT Section 3.4 a 3 points calibration certificate is to be included, will the 3 points values required be provided?
A 3 point calibration certificate is required as proof of guaranteed error of no more than \pm 0.5C at each calibration point. The testing points are not required to be provided.

No, The Environmental Monitoring Systems (EMS) must include audible and visible alarms for each freezer and refrigerator, as per Section 4.8 of Annex A

Answer 14	DND will not be providing this list in advance of contract award, but bit it is not anticipated that there will be any issues in finding GSM providers in the locations that monitoring is required. It is the vendor's responsibility to set-up network requirements with cellular provider(s) as per 2.1.2.2 of Annex A.
Question 15	ANNEX A - STATEMENT OF REQUIREMENT Section 5.9.1- Unlimited number of alarms to be sent by text message, phone, e-mail: For phone and text messages, can a list of how many users will be sent texts and calls be provided?
Answer 15	No, an unlimited number of users is required and DND will not provide a listing of how many users are required to receive phone and text message notifications.
Question 16	Please kindly confirm expected completion date(s), and hours of work available. Will work be expected to be completed on weekends? After hours? Or during regular business hours?
Answer 16	All deliverables for the Initial Contract period must be received on or before 30 August 2023. There are no restrictions on the expected days of the week and time of day for installation to take place. The vendor can co-ordinate with the local bases to complete installation at a mutually agreed upon time.
Question 17	Is it required that sensors be capable of storing data locally at the sensor itself, or is storing data at the Cloud level sufficient?
Answer 17	The sensors and/or gateways must be able to store data in the event of internet outage. Once the data is stored in the cloud, it does not need to be stored locally.
Question 18	Is a FDA 21 CFR Part 11 compliant solution required?
Answer 18	The Environmental Monitoring Systems (EMS) must have a software compliant with the Food and Drug Administration's (FDA's) part 11 of Title 21 of the Code of Federal Regulations; Electronic Records; Electronic Signatures (21 CFR Part 11).
Question 19	Do you require colour-coded alarm bands to be visible on the chart view of the data for quick analysis of alarm conditions?
Answer 19	Color-coded alarm bands on the chart view of the data is not a mandatory requirement.
Question 20	Do you require automatic report generation to be emailed directly to end-users?
Answer 20	This is not a mandatory requirement
Question 21	Do you require Canadian based service personnel?
Answer 21	This is not a mandatory requirement, however all service personnel coming on site must meet the security requirements as outlined in section 7.3, Annex C and Appendix 1 to Annex C.

Question 22	Do you require 24/7 response time? If not, what is the expected response time?
Answer 22	There are no timelines stipulated by DND in the RFP regarding response times for tickets raised by DND. As per section 25 of Appendix 3 to Annex C, upon request by DND, the Contractor must provide a document that describes the Contractor's Security Incident Response Process. Please refer to this section of the RFP for more information regarding the contractor's responsibilities regarding security incident management. In addition, the contractor must report any security incident that they have identified to the DND Project Lead by no later than 24 hours after it has been detected or reported to PSPC (as per 2.4.4 to Appendix 2 to Annex C).
