### AMENDMENT 04 TO SOLICITATION NUMBER W6369-23-A077 IS RAISED TO:

1. Provide clarification and answers to questions from potential suppliers.

## **QUESTIONS AND ANSWERS:**

Question 4	M2 (2c) -What does it mean to be self-closing?
Answer 4	When user is to open the freezer door, it should be able to swing back shut without human assistance.
Question 5	M2 (2d)- Would you please confirm if a single key will suffice because wording looks like it's singular?
Answer 5	Yes, a singular key lock will suffice, however it must have a minimum of 2 keys to open it, so different people can have a key to the freezer.
Question 6	M2-(4) - There is no mention of distance from which sound Density will be measured, is 48.6db is acceptable?
Answer 6	The noise from the operating freezer must not exceed a maximum 53 dB(A) at 1 meter. Meaning 48.6 db is acceptable.
Question 7	M3 (1) - Will Painted Steel (Stainless Steel Option) / Painted Steel be accepted?
Answer 7	Yes, that is acceptable.
Question 8	M5 (3 & 4) - In the company's manual, there is no wording for this, but pages show display screen, and it is clearly evident that temp is monitored in min 1 degree Celsius. Will it be acceptable?
Answer 8	Yes, this should be acceptable if clearly shown in the images.
Question 9	Regarding the optional years and quantity and delivery. With 700 box units, the company typically doesn't stock this so how much advance notice would you give us? (Just want to understand expectations. would you be expecting immediate delivery, or will we get couple of months advance notice?).
Answer 9	The delivery window of options is not specified in the RFP and will be mutually agreed upon by DND and the vendor. DND accepts that delivery of items on execution of options may be 3+ months.
Question 10	Regarding section 6. CERTIFICATION AND COMPLIANCE, do you accept a UL certified freezer?
Answer 10	DND would accept UL certified freezers, as long as they are recognized by SCC.
Question 11	Regarding requirement 3.1.7 which states Freezer must be environmentally friendly with low ozone depletion potential and comply with 2003 Federal Halocarbon Regulations. Can you advise what specifications must exactly be checked by vendors

	for compliance with 2003 Federal Halocarbon Regulations? Does a freezer comply with 2003 Federal Halocarbon Regulations if it uses a non ODP refrigerant (Ozone Depletion Potential = 0)?
Answer 11	The Freezer must meet all of the regulations as specified in the <u>Federal Halocarbon</u> <u>Regulations, 2003, SOR/2003-289</u> . It is the vendor's responsibility to ensure that the device they submit for tender is in compliance with all of these regulations.
