AA) Pre and Post Bidders' Conference and Bidders' Conference Solicitation Questions

Question: Appendix E.6 I'm requiring clarification for the E.6 All Risk Property Insurance, is there another name or way for this to be classified? Is this a part of the Commercial General Liability Insurance or additional insurance?

Answer: This is for insuring any government property in the shipyard for this project. This can be included as a part of one of the other insurances required, as long as all its requirements are clearly added, mentioned and covered.

Question: Will the contractor have the access to the VPM scores after the scores have been finalized after the end of the contract? Will the scores be shared with the shipyard?

Answer: Yes, the scores will be shared with the shipyard/ contractor carrying out the VLE project.

Question: Do you know if there is a way to download all of the documents at once in the technical data package?

Answer: A new link has been added to the top of the database that will allow you to download all documents at once.

Question: We would like to request an Extension to the Bid closing date for solicitation F7049-210183/A - CCGS Leonard J. Cowley -VLE Drydocking for a 45 day extension to the Bid closing date.

Question: We are requesting a 3-week extension to the closing date for the CCGS Leonard J. Cowley -VLE DRYDOCK.

Answer: Taking the vessel schedule into account, the maximum extension that can be granted is of two weeks. The date and time for submission of bids is now extended to March 07th 2023

Question: Due to the long lead times of up to 9 months for some large ticket items, (For example Winches replacement) and the payment of said items prior to starting the manufacturing of the spec item will there be compensation for the winning vendor?

Answer: We can address such claims by including them in project progress payments as long as the proof of payment to the vendors is submitted by the contractor.

BB) Specification (Annex A) Related Questions

Question: I cannot locate the "Glamox Lighting Survey" referred to in SOW Spes Item L-01, 3.1.1. Would you be able to provide this document to us?

Answer: These have now been uploaded and can be found in the Technical Data Package (the link for which was provided earlier), under L-01.

Question: When will the additional items for the Specifications be made available?

Question: Can there be an allowance introduced for the specification item H-27 Port and Starboard Main Engine Overhaul?

Answer: The additional and removed items are now available in the attachment to this Amendment 1.

The CCGS Leonard J Cowley – Spec (Annex A) is being replaced by CCGS Leonard J Cowley – Spec Rev 1 (Annex A Revision 1). In addition to the additional and removed items, there are also some modifications to the existing items in CCGS Leonard J Cowley – Spec Rev 1 (Annex A Revision 1).

The additional/ removed specification items to/ from Annex A have been marked as added/ removed in Annex A Revision 1.

The modified specification items from Annex A have been mentioned as "Updated" in Annex A Revision 1. The deletion of any wording from the individual specification item is ~~crossed-out~~, while the newly introduced wording has been **highlighted** in Yellow.

An allowance has been introduced for the specification item H-27 Port and Starboard Main Engine Overhaul in the attached Annex A Revision 1.

Question: What is the lube oil density and viscosity for the flushing of the hydraulic system, I can't find the info in the specs for the correct Flushing Fluid.

Answer: Unsure what spec is being referred to as there are multiple that discuss hydraulics. For any flushing of hydraulic systems, use the same brand, type and viscosity that is being used in the system.
