Solicitation Amendment 004

This amendment is raised to provide responses to bidder questions.

Q7. Our question of clarification relates to Section 2.1, p. 19, bullet point:

Access to one-to-one sessions with a trained coach. Up to 125 sessions per e-learning program will be provided, for a total of 500 sessions per year. Each session is defined as 30-minute appointment, with a follow up email and Action Plan. Where an Action Plan is deemed unnecessary, no plan will be sent;

Is the working assumption that each participant receives one 30-minute session with a trained coach? Or, could the number of sessions per participant vary, provided the total of 500 sessions per year is met?

A7. The intent is that each participant receives one 30-minute session with a trained coach per each e-learning program; however, there could be additional sessions with a participant if it is felt there is a need. These additional sessions would be included as part of the total of 500 sessions per year.

All other terms and conditions remain the same.
