#### **QUESTIONS AND ANSWERS**

Q1. Can you identify when year 1 would start and end? For example, is year 1 ending March 31, 2023?

A1. From date of contract award, to one year later. Example contract awarded August 1, 2023, ends July 31, 2023

Q2. Annex A, Para 10.0 states that the contractor must perform a training course with each system, however Annex B, line 2 includes a separate line item for training only in Ottawa. Can you please clarify if the bidder is supposed to include the cost of training at any of the locations listed in Annex A, Para 10.0 with Annex B, line 1?

A2. Training will only be required in Ottawa for initial delivery. No training to take place in regions listed.

Q3. Annex D, M31 references a "built-in rechargeable battery", will a battery that is removable and separately chargeable meet the requirements?

A3. No issues with a removal and chargeable from the panel

Q4. Annex A, 5.1.5 mentions the need for Technical Publications to be provided in English, however Annex A, 11.0 mentions that all deliverables must be in English and French. Can you please clarify if the technical publications, such as the user manual, must be English, French, or Bilingual?

A4. ENGLISH

Q5. Annex B, Basis of Payment, appears to have a typo in the Extended Price evaluation, where D is calculated as a multiplicative, where it should be a summation.

A5. Correct please see updated Annex B

Q6. Annex D, third column, "Documentation to Provide with Offer" appears to be information that was meant to be included in the RF50. Can you please confirm that this column was left blank intentionally? If not, can you please clarify what documentation may be required to be submitted with the bid?

A6. Any technical manuals and operations/user manuals to support mandatory component
