Question 24	For locations that don't have Floor Plans included in the RFP doc, can we assume that the units to be monitored are in the same 30M radius area? (Want to make sure I can quantify the # of Gateways/Receivers needed).

Question 25	Some of the quantities of equipment to be monitored differ from the APPENDIX 1 TO ANNEX A - LOCATIONS OF ASSETS TO MONITOR list, to the APPENDIX 3 Layouts. For instance, Appendix 1 lists qty. 1 (-20) and qty. 6 fridge for Kingston, and the Layout in Appendix 3 shows 6 fridges and 3 (-20)'s. Should we use the quantities as listed in Appendix 1 as appropriate quantities for pricing?
Answer 25	Use Appendix 1 to Annex A – Locations of Assets to Monitor List
Question 26	ANNEX A, Section 4, 4.8, states, "The Environmental Monitoring Systems (EMS) must include audible and visible alarms for each freezer and refrigerator." Does this mean that the vendor's hardware must have audible/visual Alert on the piece of equipment being monitored?
Answer 26	Yes
Question 27	ANNEX A, Section 4, 4.6, states, "The Environmental Monitoring Systems (EMS) must be ready to transmit data to the web-based platform (software) over cellular network and Ethernet. Does this mean using local network to connect data to Cloud is acceptable?
Answer 27	Yes


