INVITATION TO SUBMIT AN EXPRESSION OF INTEREST (EOI) AS TO THE AVAILABILITY OF RESIDENTIAL SPACE FOR LEASE IN THE HAMLET OF POND INLET, NUNAVUT

The Royal Canadian Mounted Police (RCMP) is asking interested Registered Inuit Firms and other parties to provide information for residential units to meet current and/or possible future requirements, including:

- Two (2) bedroom units and one (1) energized parking space per unit;
- Three (3) bedroom units and one (1) energized parking space per unit;

Section A: Lease Components

- a lease term of approximately 10 years, commencing on or about August 1, 2022, with the Lessee's option for two additional 5 year terms.
- the proposed space should satisfy or be capable of satisfying the following criteria:
 - 1. Each proposed residential unit must be an individual residential dwelling that may form part of a duplex, four plex, townhouse or row-house; and be no more than two (2) storeys in height;
 - 2. The residential units must include: a living room, dining area, kitchen with full stove, one full bathroom including tub and shower, on site laundry with full size washer and dryer and sufficient residential storage space;
 - 3. The physical characteristics of the land, the building, the surrounding area/environment, including neighbouring land uses, shall be compatible with the Lessee's intended use of the accommodation;
- The proposed space must be located within the Hamlet of Pond Inlet from whom the interested party or parties will lease the Land if awarded a lease contract by the RCMP;
- The RCMP will reserve the right to terminate a lease of any or all units with 90 days' notice prior to the intended early termination date:
- The RCMP will reserve the right to install in/on proposed space, equipment to monitor fuel, water and electricity consumption;
- proposed residential unit(s) must, on or before the lease commencement date, comply with:
 - 1. the Canada Labour Code as applicable to fire, health and safety;
 - 2. the Canadian Electrical Code;
 - 3. the National Building Code of Canada;
 - 4. all other applicable Codes and Standards and all local laws and by-laws.

Note: The RCMP may wish to visit or inspect the proposed space upon reasonable notice and a threat and risk assessment may be undertaken in order to assess potential threats to the security of the proposed space and to the public.

Information provided by interested parties or agents of interested parties should include the the proposed lot number and location of the residential unit(s), the size of the proposed residential unit(s), copy of the proposed floor plan(s) and details addressing the criteria listed above in Section A and shall identify whether the interested party is an Inuit Firm and provide the associated Inuit Firm Registry Number. Agents submitting a response to this EOI must provide RCMP with a letter authorizing them to do so.

The RCMP reserves the right to proceed with an Invitation to Offer to Lease by inviting only parties deemed to most effectively meet specific operational, security and public safety requirements.
