**Amendment 004** is raised to supersede amendment 002 and answer bidder's question and extend bid closing date to February 27, 2023.

**Question 1:** "This nozzle is offered with a SS316 body, but with nozzles of either 2 types of stainless steel: SS303 or SS316. Do you know which version?"

**Answer 1:** The entire Nozzle can be either SS316 or SS303 but cannot be a mix of the two.

**Question 2:** "Does section 6.17.1 [shipping instructions] take precedent in all shipping related expenses?"

**Answer 2:** Yes, the contract is FCA Free Carrier. The winning bidder is responsible for coordinating the pick-up with inbound logistics. DND is responsible for the cost of picking up the unit from the location stated within section 6.17.1. If a supplier is located in the USA, taxes do not apply.

**Question 3:** How do we indicate the parts are made in the USA?

**Answer 3:** When bidding, suppliers are only required to provide the part number and NCAGE. If the part being supplied meets the definition of Canadian content, suppliers are to checkmark in between the brackets in clause 5.1.2.1
