#### A. Questions and Answers

- Q1. Can you please confirm the assumed or allotted number of days that are required to conduct the field visit?  
We request some clarity on the level of effort required to complete this task.
- A1. It is up to the Bidder to determine the level of effort required, but it is anticipated it could be approximately 3 field days.
- Q2. Further to inform the above to scope the field visit, can you please confirm if the expectations for the field visit will be to areas accessible by vehicle? Are there areas that may require hiking via foot, atvs, etc.? In addition, do you seek to ground truth every road in the area or just for potential roads that could lead to points of interest?
- A2. Assume access by vehicle at this point, with field fitting once in planning stages.
- Q3. Is there additional information on points of interest within the proposed park and/or any additional tentative plans that could be provided?
- A3. No, not at this point, planning will be completed with the assistance of Parks Canada, the Osoyoos Indian Band and the Lower Similkameen Indian Band.
