### **D) Questions and Answers**

**Q1:** Will Canada act as Prime System Integrator for this Project

**A1:** DND recognizes there are benefits to seek contracting out the Prime System Integrator responsibility, especially since it will involve a precise set of technical ability. However, the current intent is for DND to act as the Technical Authority and to have Industry fill the role of Prime System Integrator, but details remain to be clarified and subject to change.

**Q2:** Is the Project Implementation Plan now to simply tender IaaS and PaaS deliverable components separately through ITQs process?

**A2:** The plan is to submit a final ITQ and then go through a draft RFP before submitting a final RFP to source a contractor as System Integrator. IaaS and PaaS are certainly possible but other options may also be considered. We have not yet determined if there will be single RFP or if there will be multiple.

**Q3:** Will Canada seek to contract out individual components of the Project separately?

**A3:** Canada is still considering all contract options. While separate contracts for individual components is one possibility, we would also consider a one-contract option. No decision has been made yet, and we remain open to suggestions from industry.

**Q4:** What will be the ISS concept for ITI in Sp of C2 and how will this be coordinated with other major capital initiatives now underway such as Net C2 ISAC, CD DAR and ICAM.

**A4:** Canada has not yet determined the ISS concept for ITI in Sp of C2 project. Please refer to RFI Amendment No. 005 – Q47 for further information.

**Q5:** As written, the ITQ would seem to be targeted to only Cloud hyper-scalers – was this the intent?

**A5:** Although the draft and final ITQ is for the provision of classified cloud services, we are seeking feedback from industry that could provide an ITI solution., The funded engagement is an opportunity for industry to provide written feedback to assist Canada to further refine its requirement, and assist Canada to understand industry capabilities. . Suppliers that have suggestions on how DND should procure a potential cloud solution are encouraged to include that information in their draft ITQ response.

**Q6:** Why is there a space diversity requirement for data centers of 1500 KM ( M 7) What threat was this intended to mitigate? Request that this distance be reduced to 300 KM or dropped altogether.

**A6:** The space diversity requirement of 1500 km represents our current best understanding of how to meet the high level system requirements of the capability we will be putting in place. At this point in time, Canada has no intent to change this requirement.

**Q7:** At Attachment 1 to Part 4 of the ITQ (Evaluation Procedures and Basis of Selection) – 4.1 Technical Evaluation Criteria, Section 2.0 – Table 1, Item M18, both the stated requirement and information required in the bidders response are inappropriate Mandatory Technical Requirements. Has PSPC inserted these requirements in the Terms and Conditions of any other GC contract? It is requested that this mandatory be dropped.

**A7:** Canada has had a variety of financial Mandatory Criteria in other requirements. We encourage organizations provide feedback on specific sections as part of their response to the draft ITQ.

**Q8:** Is it possible to share the SECRET Facility Security Clearance (FSC) and Document Safeguarding capability requirements relevant to the ITI in Sp of C2 project beyond the ITQ stage?

**A8:** Canada will provide the SECRET FSC and Document Safeguarding capability requirements relevant for the RFP and Contract stage as soon as available. For the post ITQ funded engagement please see the SECRET FSC and DSC requirement in Section 7.3 – Security Requirements of the draft ITQ.

**Q9:** On page 94 of the Amendment 20 PDF, there is a table for feedback, which seems to request that the feedback for Mandatory Technical Evaluation Criteria be included. On pages 95 and 96, there is another table, which seems to be dedicated to the Mandatory Technical Evaluation Criteria.

Would you like us to have two sheets in our Excel response workbook file? One sheet will have our feedback on everything except the Mandatory Technical Evaluation Criteria and the second sheet will have only our feedback on the Mandatory Technical Evaluation Criteria (based on the format of the table provided on pages 95 and 96).

**A9:** Yes, the intension is to have both forms filled out as stated.

**Q10:** Suppliers are instructed to use "provided spreadsheet to provide their feedback". However, no excel spreadsheet was attached to the ITQ documents. Please advise if suppliers are to create an excel spreadsheet based on the format on Page 96 of Amendment 20 to submit their feedback and comments to the Draft ITQ.

**A10:** Only a PDF copy was made available in RFI Amendment No. 20. Please reference the attached fillable Excel documents to this amendment.

**Q11:** Please clarify the closing date for feedback and comments on the Draft ITQ. The Solicitation Cover Sheet states March 31; however, the Instructions to Suppliers lists March 24.

**A11:** The Solicitation Cover Sheet date of March 31, 2023 is in reference to the larger Request for Information (RFI) closing date, which has subsequently been amended as a result of this solicitation to March 29, 2024.

Within regards to supplier instructions for the Draft ITQ, that is in reference to the Draft ITQ feedback request date, which has been revised to April 14, 2023. Please see above for further information.

**Q12:** We would like to request a copy of Amendment 20 in Word format.

**A12:** Unfortunately, we can only provide issued amendment copies in PDF format, which can be found on [CanadaBuys](#).

**Q13:** We have carefully reviewed the Draft ITQ requirements and respectfully request a three-week extension to prepare a comprehensive response.

**A13:** Canada will grant a one time three-week extension for interested suppliers to provide feedback, comments, questions and suggestions to the draft ITQ. In an effort to remain within project schedule, any additional requests for an extension may not be considered. Please see above for further information.

**Q14:** The guidance in the Draft ITQ for ITI in Sp of C2 Project clearly states that a respondent cannot be a subcontractor to for the final ITQ. As this is not the final ITQ, can both respondents and subcontractors submit responses directly to the Crown in regard to the DRAFT ITQ

**A14:** Acceptable feedback responses to the Draft ITQ can be done through a partner, directly or both.

**Q15:** We would like to request a list of Government of Canada attendees and their titles to better understand who we presented to during Draft ITQ Industry Engagement 1-on-1 sessions for the period between February 7 to 17, 2023.

**A15:** Names of only key Government of Canada stakeholders invited to attend the 1-on-1 sessions can be disclosed. Actual attendance may have varied between meetings due to scheduling conflicts, however similar stakeholders would have attended as replacements. Please reference Annex A to this RFI Amendment document.

**Q16:** As part of the Vendor Q&A process, guidance was given to request assistance for the process to gain SECRET Site Clearance for the ITI in Sp of C2 Project. Is there a contact/group who we could work with to start the SECRET Site process?

**A16:** As per instructions in the draft ITQ, please contact the Contract Security Program (CSP) of Public Works and Government Services Canada.
