Question 1	<p>There are requirements in items 4.1.1.a,i,ii,iii,iv,v,vi,vii and 4.1.3.b,i,ii that prevent us from bidding on this unit. They are “must supply” items.</p> <p>In the Industry of commercially produced light duty trucks, both Ford and GM, there are no available searchable parts manuals in a CD/DVD-ROM format, unless the client pays a monthly subscription of +/- \$ 650./month.</p> <p>All Ford and GM dealers pay this subscription. We cannot include a subscription such as that in a normal tender.</p> <p>We would like to quote a Ford F550 chassis. There are 350+ Ford dealers in Canada who can respond to any parts inquiry (with a valid serial number).</p> <p>The dealer can print out a parts diagram and part number if necessary.</p> <p>The DND has many Ford Super Duty truck of this nature and I am sure the mechanics have no problems ordering parts.</p>
Answer 1	<p>The Maintenance and Parts manuals will be accepted on a USB key.</p>
Question 2	<p>Are there drawings to be done?</p>
Answer 2	<p>Yes, basic drawings: cabin, chassis, platform will be required</p>
Question 3	<p>What time of welding machine do you want?</p>
