PART 1 - GENERAL INFORMATION

1.1 Introduction

The bid solicitation is divided into seven parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation;
- Part 3 Bid Preparation Instructions: provides Bidders with instructions on how to prepare their bid;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria that must be addressed in the bid, and the basis of selection;
- Part 5 Certifications and Additional Information: includes the certifications and additional information to be provided;
- Part 6 Security, Financial and Other Requirements: includes specific requirements that must be addressed by Bidders; and
- Part 7 Resulting Contract Clauses: includes the clauses and conditions that will apply to any resulting contract.

The Annexes include the Technical Statement of Requirement, the Basis of Payment, Subcontractor, the Insurance Requirements, Bidder Questions and Canada Responses and Warranty Claim.

1.2 Summary

- 1.2.1 Parks Canada has a requirement to purchase one (1) 6.5-6.7 meter Aluminum Marine Craft with trailer and engine, built in accordance with the Technical Statement of Requirement (TSOR) Annex "A".

Delivery

The completed vessels and deliverables must be delivered on or before **March 31st, 2024**.

1.2.2 This requirement is subject to the Canada Free Trade Agreement (CFTA).

1.2.3 This bid solicitation allows bidders to use the CPC Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

1.2.4 This procurement is subject to the following Comprehensive Land Claims Agreement(s):
a. Labrador Inuit Land Claims Agreement (2005) (Modern Treaty Areas)

1.3 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.4 Restriction on Bidding

This is a bid solicitation for construction of ship(s) that are less than 1000 tonnes in lightship displacement. The two shipyards selected by Canada under the National Shipbuilding Strategy for the combat and non-combat vessel work packages are not eligible to bid on it. Accordingly, neither Irving Shipbuilding Inc., Vancouver Shipyards Company Ltd., nor any of their subsidiaries or affiliates nor the person who controls any of them ("subsidiary", "affiliate," "control" and "person" are all as defined in the Canada Business Corporations Act. R.S.C. 1985, c C-44 as amended) is eligible to submit a bid or be awarded a contract for the work of this bid solicitation. By submitting a bid to this bid solicitation, a bidder is certifying that it is in compliance with the above restriction. It is a term of any contract that results from this solicitation that if this certification is untrue, whether made knowingly or unknowingly, Canada shall have the right, pursuant to the default provisions of the resulting contract, to terminate the resulting contract for default.

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The [2003](#) (2022-03-29) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2.1.1 SACC Manual Clauses

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated in the bid solicitation.

Note: For bidders choosing to submit using Canada Post Corporation's (CPC) Connect service for bids closing at the Bid Receiving Unit in the National Capital Region (NCR) the email address is:

Note: Bids will not be accepted if emailed directly to this email address. This email address is to be used to open a CPC Connect conversation, as detailed in Standard Instructions [2003](#), or to send bids through a CPC Connect message if the bidder is using its own licensing agreement for CPC Connect service.

Due to the nature of the bid solicitation, bids transmitted by facsimile to PWGSC will not be accepted.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2.5 Improvement of Requirement During Solicitation Period

Should bidders consider that the specifications contained in the bid solicitation could be improved technically or technologically, bidders are invited to make suggestions, in writing, to the Contracting Authority named in the bid solicitation. Bidders must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular bidder will be given consideration provided they are submitted to the Contracting Authority at least 5 days before the bid closing date. Canada will have the right to accept or reject any or all suggestions.

2.6 Bid Challenge and Recourse Mechanisms

- (a) Several mechanisms are available to potential suppliers to challenge aspects of the procurement process up to and including contract award.
- (b) Canada encourages suppliers to first bring their concerns to the attention of the Contracting Authority. Canada's [Buy and Sell](#) website, under the heading "[Bid Challenge and Recourse Mechanisms](#)" contains information on potential complaint bodies such as:
- Office of the Procurement Ombudsman (OPO)
 - Canadian International Trade Tribunal (CITT)
- (c) Suppliers should note that there are **strict deadlines** for filing complaints, and the time periods vary depending on the complaint body in question. Suppliers should therefore act quickly when they want to challenge any aspect of the procurement process.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Canada requests that the Bidder submits its bid in accordance with section 08 of the 2003 standard instructions. The CPC Connect system has a limit of 1GB per single message posted and a limit of 20GB per conversation.

Canada requests that the Bidder submits its bid in separately bound sections as follows:

Section I: Technical Bid
Section II : Management Bid
Section III: Financial Bid
Section IV: Certifications

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Due to the nature of the bid solicitation, bids transmitted by facsimile will not be accepted.

3.2 Section I: Technical Bid

In their technical bid, Bidders should demonstrate their understanding of the requirements contained in the bid solicitation and explain how they will meet these requirements. Bidders should demonstrate their capability and describe their approach, in a thorough, concise and clear manner for carrying out the work.

The technical bid must demonstrate the vessel will be fully seaworthy, operable and fit in all regards for the purposes intended.

The technical bid should address clearly and in sufficient depth the points that are subject to the evaluation criteria against which the bid will be evaluated. Simply repeating the statement contained in the bid solicitation is not sufficient. In order to facilitate the evaluation of the bid, Canada requests that Bidders address and present topics in the order of the evaluation criteria under the same headings. To avoid duplication, Bidders may refer to different sections of their bids by identifying the specific paragraph and page number where the subject topic has already been addressed.

Bidders must also provide all information/documentation requested under section 4.1.1.1.

3.3 Section II : Management Bid

In their management bid, Bidders must describe their capability and provide all documentation/information as requested in articles 4.1.2.1, 4.1.2.2, 4.1.2.3, and 4.1.2.4.

3.4 Section III: Financial Bid

3.4.1 Bidders must submit their financial bid in accordance with the Basis of Payment in Annex "B".

3.4.2 Exchange Rate Fluctuation

The requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All bids including such provision will render the bid non-responsive.

3.4.3 Unscheduled Work

Bidders must provide the information requested in the Basis of Payment, Annex "B" Charge-out Rate / Material Mark-up.

The unscheduled work rates will be included in the Basis of Payment, however it will not form part of the bid evaluation.

3.5 Section IV: Certifications

Bidders must submit the certifications and additional information required under Part 5.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

4.1 Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the Technical and Financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.

4.1.1 Technical Evaluation

4.1.1.1. Mandatory Technical Criteria

In order to be compliant, Bidder's proposal must, to the satisfaction of Canada, meet all requirements of the TSOR and provide all information as requested in PART 3 - BID PREPARATION INSTRUCTIONS, 3.2 Section I - Technical Bid.

A mandatory requirement is described using the words "shall", "must", "will", "is required" or "is mandatory".

4.1.1.2 Proven Aluminum Vessel Construction Experience

Bidders must provide documentation for a minimum of two proven marine vessels of similar size, type and complexity to the requirement of this RFP which have been produced and in service within the last ten years. A prototype hull will not be considered for this requirement.

For the purposes of this evaluation, the terms similar size and type are defined as follows:

Similar size: 6.5m to 6.7m in length

Similar type: Aluminum construction experience
Complexity: Non-pleasure craft built and registered in accordance with TP 1332

Documentation required for each proven vessel must include:

- i. Hull identification numbers (HIN) from Transport Canada or equivalent to HIN if registered outside Canada;
- ii. Photos;
- iii. Draft stability calculations;
- iv. Calculated lightship weight;
- v. General Arrangement drawings;
- vi. Structural drawings showing deck plan, a centerline profile, and frame station construction details;
- vii. Detailed lines plan; and
- viii. Drawing of fuel supply arrangement

4.1.2 Management Evaluation

In order to be compliant, Bidder's proposal must, to the satisfaction of Canada, meet all requirements and provide all information as requested in **PART 3 - BID PREPARATION INSTRUCTIONS, 3.3 Section II – Management Bid.**

4.1.2.1 Marine Drafting and Engineering Capability

The Bidder must provide objective evidence that it has either in-house capabilities, or has a written commitment for the duration of the Contract from a supplier to provide marine drafting and engineering services. The bidder or subcontractor must have the marine drafting and engineering experience and capabilities on construction projects for boats of similar size and type to the boats subject to this RFP.

4.1.2.2 Project Schedule

1. As part of its technical bid, the Bidder must provide a preliminary project schedule, in MS Project format or equivalent, indicating the sequence and the completion dates of major project milestones, deliverables, and project tasks based on a contract award as "day 0." The project schedule should include the Bidder's work breakdown structure, the scheduling of main activities and milestone events and any potential problem areas involved in completing the Work.

2. The Bidder's schedule must also provide a target date for each of the following significant events for each boat as applicable:

- a) Hull materials delivered to Contractor and sustained construction commenced;
- b) Hull and deck completed, but not closed in to allow for full inspection of the structure;
- c) Outfitting/electrical 75% complete but all equipment and components delivered to the Contractor and available for full inspection;
- d) Technical manuals delivered to Canada for review and approval (no less than 14 days prior to the planned delivery date);
- e) Contractor's tests and trials and final sea trials required by the TSOR;
- f) Boat, trailer and technical manuals delivered to Canada for final acceptance at destination;
- g) Start and the end of the 12 month warranty period.

4.1.2.3 Subcontractors

A list, in the form of the attached **Annex "C"** of subcontracts for labor and/or material must be included with the Bidder's Proposal, stating the name and address of each subcontractor, and a description (Make, Model No.) of the goods or services to be supplied by each.

4.1.2.4 Contractor Quality Management System

1. The Supplier must provide objective evidence that it has a Quality Assurance Program, which must be in place during the performance of the Work, and which addresses the quality control elements below.
2. The quality control elements must include, as a minimum:
 - a. Quality Assurance Manual or Quality Assurance Program Descriptions
 - b. Inspection and Test Plan
 - c. Final Inspection
 - d. Quality Records
3. The objective evidence may be in the form of a copy of the Supplier's Quality Assurance Manual which addresses these elements.
4. The Supplier must also provide a minimum of one (1) sample of completed quality records used on the most recent marine vessel construction at its facility.

4.1.3 Financial Evaluation

The price of the bid will be evaluated in Canadian dollars, Applicable Taxes excluded, FOB destination, Canadian customs duties and excise taxes included.

4.1.3.1 Mandatory Financial Criteria

In order to be compliant, Bidder's proposal must, to the satisfaction of Canada, meet all requirements and provide all information as requested in PART 3 – BID PREPARATION INSTRUCTIONS, 3.3 Section II – Financial Bid and Annex "B" – Basis of Payment.

4.2 Basis of Selection

4.2.1 Mandatory Technical Criteria

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical and management evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

A mandatory requirement is described using the words "shall", "must", "will", "is required" or "is mandatory".

PART 5 – CERTIFICATIONS AND ADDITIONAL INFORMATION

Bidders must provide the required certifications and additional information to be awarded a contract.

The certifications provided by Bidders to Canada are subject to verification by Canada at all times. Unless specified otherwise, Canada will declare a bid non-responsive, or will declare a contractor in default if any certification made by the Bidder is found to be untrue, whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

Bidders must submit the following duly completed certifications as part of their bid.

5.1.1 Integrity Provisions - Declaration of Convicted Offences

In accordance with the Integrity Provisions of the Standard Instructions, all bidders must provide with their bid, **if applicable**, the Integrity declaration form available on the [Forms for the Integrity Regime](http://www.tpsgc-pwgsc.gc.ca/ci-if/declaration-eng.html) website (<http://www.tpsgc-pwgsc.gc.ca/ci-if/declaration-eng.html>), to be given further consideration in the procurement process.

5.2 Certifications Precedent to Contract Award and Additional Information

The certifications and additional information listed below should be submitted with the bid but may be submitted afterwards. If any of these required certifications or additional information is not completed and submitted as requested, the Contracting Authority will inform the Bidder of a time frame within which to provide the information. Failure to provide the certifications or the additional information listed below within the time frame specified will render the bid non-responsive.

5.2.1 Integrity Provisions – Required Documentation

In accordance with the section titled Information to be provided when bidding, contracting or entering into a real property agreement of the [Ineligibility and Suspension Policy](http://www.tpsgc-pwgsc.gc.ca/ci-if/politique-policy-eng.html) (<http://www.tpsgc-pwgsc.gc.ca/ci-if/politique-policy-eng.html>), the Bidder must provide the required documentation, as applicable, to be given further consideration in the procurement process.

5.2.2 Welding Certification

1. Welding must be performed by a welder certified by the Canadian Welding Bureau and in accordance with the requirements of the following Canadian Standards Association (CSA) standards:
 - (a) CSA W47.2 Fusion Welding of Aluminum Company Certification
2. Before contract award and within 5 calendar days of the written request by the Contracting Authority, the successful Bidder must submit evidence demonstrating its certification to the welding standards.

5.2.3 Additional Certifications Precedent to Contract Award

5.2.3.1 Workers Compensation Certification- Letter of Good Standing

The Bidder must have an account in good standing with the applicable provincial or territorial Workers' Compensation Board.

The Bidder must provide, **within 5 days** following a request from the Contracting Authority, a certificate or letter from the applicable Workers' Compensation Board confirming the Bidder's good standing account. Failure to comply with the request may result in the bid being declared non-responsive.

PART 6 - SECURITY, FINANCIAL AND OTHER REQUIREMENTS

6.1 Security Requirements

There is no security requirement applicable to the Contract.

6.2 Insurance Requirements

The Bidder must provide a letter from an insurance broker or an insurance company licensed to operate in Canada stating that the Bidder, if awarded a contract as a result of the bid solicitation, can be insured in accordance with the Insurance Requirements specified in Annex "D".

If the information is not provided in the bid, the Contracting Authority will so inform the Bidder and provide the Bidder with a time frame within which to meet the requirement. Failure to comply with the request of the Contracting Authority and meet the requirement within that time period will render the bid non-responsive.

PART 7 - RESULTING CONTRACT CLAUSES

The following clauses and conditions apply to and form part of any contract resulting from the bid solicitation.

- (d) technical manuals delivered to Canada for approval (no less than 14 days prior to the planned delivery date);
- (e) Contractor's tests and trial and final sea trials required by the TSOR;
- (f) boat delivered to Canada for approval;
- (g) the start and the end of the 12 month warranty period

Note: Technical Manuals will not be returned once approved.

The schedule is to be regularly updated and available in the Contractor's office for review by Canada's authorities to determine the progress of the Work.

7.13 Progress Report

1. The Contractor must submit monthly reports on the progress of the Work in an electronic format to the Technical Authority and to the Contracting Authority.
2. The progress report must contain two Parts:
 - (a) PART 1: The Contractor must answer the following three questions:
 - i. is the project on schedule?
 - ii. is the project within budget?
 - iii. is the project free of any areas of concern in which the assistance or guidance of Canada may be required?

Each negative response must be supported with an explanation.

- (b) PART 2: A narrative report, brief, yet sufficiently detailed to enable the Technical Authority to evaluate the progress of the Work, containing at a minimum:
- i. a description of the progress of each task and of the Work as a whole during the period of the report. Sufficient sketches, diagrams, photographs, etc., must be included, if necessary, to describe the progress accomplished.
 - ii. an explanation of any variation from the schedule.

7.14 Progress Meeting

Progress meetings, chaired by the Contracting Authority, will take place at the Contractor's facility as and when required, generally once a month. Interim meetings may also be scheduled. Contractor's attendees at these meetings will, as a minimum, be its Contract (Project) Manager, Production Manager (Superintendent) and Quality Assurance Manager. Progress meetings will generally incorporate technical meetings to be chaired by the Technical Authority.

7.15 Progress Review Meeting

Progress review meeting shall encompass total project status as of the review date. The Contractor, at a minimum, must report on the following:

1. Progress to date;
2. Variation from planned progress and the corrective action to be taken during the next reporting period;
3. A general explanation of foreseeable problems and proposed solutions, including an assessment of their impact on the contract in terms of schedule, technical performance and risk. The proposed solution should include the effort involved and the consequences to the schedule (Risk Register);
4. Proposed changes to the schedule;
5. Progress on action items, problems or special issues;
6. Deliverables submitted prior to PRM;
7. Milestones (technical and financial);
8. Activities planned for the next reporting period;
9. Status of any change notifications and requests;
10. Other business as mutually agreed to by CANADA and the Contractor.

7.16 Procedures for Design Change or Additional Work

These procedures must be followed for any design change or additional work.

1. When Canada requests design change or additional work:
 - a. The Technical Authority will provide the Contracting Authority with a description of the design change or additional work in sufficient detail to allow the Contractor to provide the following information:
 - i. any impact of the design change or additional work on the requirement of the Contract;

-
- ii. a price breakdown of the cost (increase or decrease) associated with the implementation of the design change or the performance of the additional work using either the form [PWGSC-TPSGC 1686](#), Quotation for Design Change
 - iii. a schedule to implement the design change or to perform the additional work and the impact on the contract delivery schedule.
- b. The Contracting Authority will then forward this information to the Contractor.
 - c. The Contractor will return the completed form to the Contracting Authority for evaluation and negotiation. Once agreement has been reached, the form must be signed by all parties in the appropriate signature blocks. This constitutes the written authorization for the Contractor to proceed with the work, and the Contract will be amended accordingly.
2. When the Contractor requests design change or additional work:
- a. The Contractor must provide the Contracting Authority with a request for design change or additional work in sufficient detail for review by Canada.
 - b. The Contracting Authority will forward the request to the Technical Authority for review.
 - c. If Canada agrees that a design change or additional work is required, then the procedures detailed in paragraph 1 are to be followed.
 - d. The Contracting Authority will inform the Contractor in writing if Canada determines that the design change or additional work is not required.

3. Approval:

The Contractor must not proceed with any design change or additional work without the written authorization of the Contracting Authority. Any work performed without the Contracting Authority's written authorization will be considered outside the scope of the Contract and no payment will be made for such work.

7.17 Insurance Requirements

7.20 Manuals

1. No later than 14 calendar days prior to delivery of each boat, the Contractor must obtain and deliver to the Technical Authority for approval all Data Books, Operating Instruction Books, Maintenance Manuals and Spare Parts Lists (including part numbers and ordering instructions) for all machinery and equipment fitted on the Vessel as required. Once approved by the TA, the Contractor will provide 2 complete copies in accordance with and as specified in the TSOR.
2. Where manuals are examined by Canada, such examination does not relieve the Contractor of any responsibility under the Contract for ensuring the correctness of all details and adequacy of performance of the Vessel, nor does it obligate Canada to accept, in part or in whole, an item of Work completed in accordance with such manual, nor does it mean such an item of Work meets the requirements of the TSOR.

7.21 Acceptance

1. Canada's provisional acceptance for delivery of the vessel must occur with the execution of a certificate in accordance with form **PWGSC 1105** upon satisfactory completion of the vessel and all trials. The execution of the certificates must in no way relieve the Contractor of any obligations under the Contract.
2. It is understood and agreed that where the work has been substantially completed and the parties have agreed upon the terms and conditions for the Contractor to make good any deficiencies, the certificate referred to above may be executed with a statement attached concerning the rectification of the deficiencies by the Contractor.
3. Canada's final acceptance must occur upon completion of the 12 month warranty period and settlement of all accounts between the parties in relation to the Contract.

7.22 Dispute Resolution

- (a) The parties agree to maintain open and honest communication about the Work throughout and after the performance of the contract.
- (b) The parties agree to consult and co-operate with each other in the furtherance of the contract and promptly notify the other party or parties and attempt to resolve problems or differences that may arise.

- (c) If the parties cannot resolve a dispute through consultation and cooperation, the parties agree to consult a neutral third party offering alternative dispute resolution services to attempt to address the dispute.

7.23 WARRANTY CLAIM PROCEDURES

Reporting Failures with Warranty Potential

1. The initial purpose of a report of a failure is to facilitate the decision as to whether or not to involve warranty and to generate action to effect repairs. Therefore in addition to identification, location data, etc. the report must contain details of the defect. Warranty decisions as a general rule are to be made locally and the administrative process is to be in accordance with procedures as indicated.
2. These procedures are necessary as invoking a warranty does not simply mean that the warrantor will automatically proceed with repairs at their expense. A review of the defect may well result in a disclaimer of responsibility, therefore, it is imperative that during such a review the Department is directly represented by competent technical authority qualified to agree or disagree with the warrantor's assertions.

Procedures

3. Immediately it becomes known to the vessel staff that an equipment/system is performing below accepted standards or has become defective, the procedures for the investigation and reporting are as follows:
 - a. On review of the specification and the acceptance document, the Technical Authority is to complete section 1 of the Warranty Claim Form (copy attached as Appendix 1) and forward the original to the Contracting Authority. A copy will then be forwarded to the Contractor. If the Contracting or Inspection Authority is unable to support warranty action, the Defect Claim Form will be returned to the originator with a brief justification. It is to be noted that in the latter instance PWGSC will inform the Contractor of its decision and no further action will be required of the Contractor.
 - b. Assuming the Contractor accepts full responsibility for repair, the Contractor completes Section 2 and 3 of the Claim Form, returns it to the Inspection Authority who confirms corrective action has been completed, and who then distributes the form to the Technical Authority and PWGSC Contracting Authority.
 - c. In the event that the Contractor disputes the claim as a warranty defect, or agrees to share, the contractor is to complete Part 2 of the Claim Form with the appropriate information and forward it to the Contracting Authority who will distribute copies as necessary;
4. When a warranty defect claim is disputed by the Contractor, the Technical Authority may arrange to correct the defect by in-house resources or by contracting the work out. All associated costs must be tracked and recorded as a possible charge against the Contractor by PWGSC action. Material costs and man-hours expended in correcting the defect are to be recorded and entered in Section 5 of the warranty defect claim by the Technical Authority who will forward the warranty defect claim to the Contracting Authority for action. Defective parts of equipment are to be retained pending settlement of claim.
5. Defective equipment associated with potential warranty should not normally be dismantled until the Contractor's representative has had the opportunity to observe the defect. The necessary work is to be undertaken through normal repair methods and costs must be segregated as a

possible charge against the Contractor by PWGSC action.

INSURANCE REQUIREMENTS

Commercial General Liability Insurance

1. The Contractor must obtain Commercial General Liability Insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$2,000,000 per accident or occurrence and in the annual aggregate.
2. The Commercial General Liability policy must include the following:
 - (a) Additional Insured: Canada is added as an additional insured, but only with respect to liability arising out of the Contractor's performance of the Contract. The interest of Canada should read as follows: Canada, as represented by Public Works and Government Services Canada.
 - (b) Bodily Injury and Property Damage to third parties arising out of the operations of the Contractor.
 - (c) Products and Completed Operations: Coverage for bodily injury or property damage arising out of goods or products manufactured, sold, handled, or distributed by the Contractor and/or arising out of operations that have been completed by the Contractor.
 - (d) Personal Injury: While not limited to, the coverage must include Violation of Privacy, Libel and Slander, False Arrest, Detention or Imprisonment and Defamation of Character.
 - (e) Cross Liability/Separation of Insureds: Without increasing the limit of liability, the policy must protect all insured parties to the full extent of coverage provided. Further, the policy must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.
 - (f) Blanket Contractual Liability: The policy must, on a blanket basis or by specific reference to the Contract, extend to assumed liabilities with respect to contractual provisions.
 - (g) Employees and, if applicable, Volunteers must be included as Additional Insured.

1. Overview

- 1.1 Parks Canada has a requirement for one Marine Craft with the primary use of bringing Parks Canada staff to the Akami-Uapishk^u-Kakkasuak-Mealy Mountains National Park Reserve from Happy Valley/Goose Bay, Cartwright and or Rigolet and return.

2. Technical Specifications

2.1 Requirement

- 2.1.1 The Contractor must design, fabricate, test and supply one aluminum Marine Craft with trailer, compliant to TP1332E.
- 2.1.2 Unless stated otherwise all components, equipment and material must be Contractor supplied.

2.2 Primary Dimensions

- 2.2.1 The Marine Craft must meet the following dimensional requirements.
 - a. Length = 6.5m to 6.7m (21' to 22').
 - b. Beam = 2.5m to 2.6m (8.2' to 8.6').
 - c. Tow weight = maximum of 953kg (2100 lb).

2.3 Performance Requirements

- 2.3.1 The Marine Craft must be able to be beached on soft surfaces at a speed of up to 5 knots without damaging the hull.
- 2.3.2 The Marine Craft must be able to be beached on hard surfaces (stone or concrete) at a speed of up to 3 knots without damaging the hull.
- 2.3.3 The Marine Craft must be designed to be operated under the Small Vessel Operator Permit.
- 2.3.4 The Marine Craft must meet Transport Canada standard TP 1332E.
- 2.3.5 All materials, fittings and hardware must be corrosion resistant and suitable for use in salt water.
- 2.3.6 The Marine Craft should have a life expectancy of 12 years with an operating time of 100 hours per year.

2.4 Hull Design

- 2.4.1 The Marine Craft must have a mono hull V-shape, designed to operate in open ocean and along rocky coastlines.
- 2.4.2 The Marine Craft hull must be made from marine grade aluminum (minimum 3/16" bottom and freeboard, 1/4" on the transom).
- 2.4.3 All welds must meet requirements of CSA W47.2-M Certification of Companies for Fusion Welding of Aluminum.
- 2.4.4 The Marine Craft must be Bow-Rider style with spilt console and walk through windshield.
- 2.4.5 The Marine Craft must have an inside level floor with sound proofing foam.
- 2.4.6 The Marine Craft must have a self bailing floor.
- 2.4.7 The Marine Craft must have an aluminum tread plate floor.
- 2.4.8 The Marine Craft must have aluminum stern and bow grab rails. (Bow = one each on port and starboard & Stern = one the entire length of the transom).
- 2.4.9 The Marine Craft must have stainless steel tie down cleats at bow and stern. (One at bow tip. One at mid-ship, port and starboard side. One at stern, port and starboard side)
- 2.4.10 The Marine Craft must have a transducer bracket.
- 2.4.11 The Marine Craft must have an aluminum radar arch at the stern.
- 2.4.12 The Marine Craft must have non-skid on gunnels.
- 2.4.13 The Marine Craft must have two swivel seats on pedestals (driver and passenger seats at windshield area).
- 2.4.14 The Marine Craft must have a full across aluminum seat at the stern with bottom cushion and back rest.
- 2.4.15 The Marine Craft must have aluminum bow wedge seats with storage compartments and hatch covers.
- 2.4.16 The Marine Craft must have storage compartment and hatch cover on passenger side console.
- 2.4.17 The Marine Craft must have two transom lockers (one on each side of transom), with minimum 18 x 28 cm (7 x 11 inches) hatch cover.
- 2.4.18 The Marine Craft must be able to have dual outboard engines installed (minimum two 90 hp outboard engines with a minimum combined weight of 800 lbs).
- 2.4.19 The Marine Craft must have hydraulic steering installed on the driver side console including wheel and cables.

2.5 Engine Requirements

- 2.5.1 The Marine Craft must have (2) two 90 HP outboard four stroke Yamaha motors or equivalent.
- 2.5.2 The Marine Craft motors must be retractable (tilt/trim motors) to allow for beaching in shallow water.
- 2.5.3 The Marine Craft motors must include a binnacle control located on the starboard side of the driver side console.
- 2.5.4 The engines must be installed, mounted and operated in accordance to the engine manufacturer's recommendation by the Contractor.

- 2.5.5 Propellers for each engine must be properly sized and installed by the Contractor.
- 2.5.6 The engine package must incorporate a lanyard style automatic shutdown feature for the engines, mounted near the ignition switches.
- 2.5.7 At the very minimum, the following indicators must be installed on the driver side console:
 - a) Fuel gauge
 - b) Tachometer
 - c) Voltmeter for the motor
 - d) Temperature gauge
 - e) Oil pressure gauge
 - f) A tilt/trim indicator for each motor

2.6 Fuel System

- 2.6.1 The Marine Craft must have internal fuel tank(s) (minimum capacity 33 gal/125 liters).
- 2.6.2 Fuel tanks and all associated lines and valves must meet the requirements of TP 1332E.
- 2.6.3 Fuel tanks must be fitted with a fuel level/capacity sensor unit and gauge on driver side console.
- 2.6.4 The fuel system must include one (1) fuel filter/ water separator per motor with clear bowl, suitable for fuel supply to the gas-powered outboard motors.

2.7 Electronics

- 2.7.1 A 12 V DC distribution system must be provided to power motor start-up and Marine Craft service loads.
- 2.7.2 The Marine Craft is to be equipped with a system of two (2) deep-cycle marine batteries, with a selector switch and connected in accordance with the motor manufacturer's technical specifications.
- 2.7.3 Marine batteries are to be located in the transom lockers, watertight and fitted with a suitable means of gas venting
- 2.7.4 All electrical equipment must be installed so as to function without causing interference to other equipment.
- 2.7.5 Electrical equipment must be readily accessible for maintenance.
- 2.7.6 The Marine Craft must have a water tight electrical panel with switches installed on the driver side console (minimum 6 circuit).
- 2.7.7 The Marine Craft must come with all navigation and running lights required by Transport Canada. All lighting must be LED. A light switch must be located on the electrical panel.
- 2.7.8 The Marine Craft must have a 1,000 gph capacity electric bilge pump. It must be located so that it takes suction from lowest point of the hull. A bilge switch must be located on the electrical panel.
- 2.7.9 The Marine Craft must have a marine grade 12 V power socket with cap.

2.8 Trailer

- 2.8.1 The Trailer must be rated to carry a minimum 953 kg (2100 lb) boat.
- 2.8.2 The Trailer must be capable of securely winching the Marine Craft from/to the water using a boat ramp.
- 2.8.3 The Trailer must be corrosion resistant from continued exposure to salt water.
- 2.8.4 The Trailer must have rear lights that indicate turning and braking functions.

- 2.8.5 The lights must be LED and be submersible in salt water.
- 2.8.6 The Trailer must have a standard electrical connector for engagement with a commercial pick-up truck.
- 2.8.7 The Trailer must come with safety chains for connecting to the truck.
- 2.8.8 The Trailer must come with a spare tire, rim mounted, located at front of trailer.
- 2.8.9 The Trailer must come with tie down straps to secure the vessel.
- 2.8.10 The Trailer must come with a drop leg, side wind jack with caster wheel and anti-reversing mechanism, sized to meet normal load condition of Marine Craft.

2.9 Tests and Trials

- 2.9.1 The Contractor must inspect and test the following items, as a minimum, for adherence to the contract requirements and proper operation (proper operation means that the equipment can be started, operated, connected together and demonstrated to function in a normal fashion, as applicable). All discrepancies must be corrected prior to delivery. The required inspections and tests are minimums and are not intended to supplant any controls, examinations, inspections or tests normally employed by the Contractor to assure the quality of the vessel. Inspections and trials target the following elements:

- a) Weight
- b) Construction quality
- c) Propulsion motor, including starting
- d) Propulsion controls
- e) Steering system
- f) Fuel system
- g) Electrical system
- h) Electronics
