AMENDMENT NO. 005

This amendment 005 is raised to answer questions related to the RFP and extend the solicitation period by an additional 21 days to April 17th, 2023.

QUESTIONS AND ANSWERS

Question 11:

To what extent does Canada intend to integrate defence-focused supply chain security features into the system?

- a. For example, if Canada intends on prohibiting the use of components originating in certain countries, this will affect the cost of producing the system and should be disclosed at the bid preparation stage.

Answer 11:

Canada does not intend to prohibit the use of components originating from certain countries.

However, following the completion of the Design Phase of the Contract, Canada will evaluate the risks associated with all components of the Power Supply System (PSS). This process will require the awarded supplier to provide specific information on all components and will be subject to a Supply Chain Integrity (SCI) process conducted by the Canadian Centre for Cyber Security (CCCS) and Communications Security Establishment (CSE) in partnership with DND to provide advice and guidance on possible and perceived risks. The SCI process will not be conducted at Contract Award.
