The amendment to the bid solicitation is to address the enquiries received::

Response(s) (R) to Question(s) (Q)1:

Q1. Could you please outline how the security clearance process works? Specifically, are bidders required to obtain these clearances ahead of submitting the proposal or will these be processed only after a contract award is made?

R1. As per Part 1, 1.1 Security Requirement of the Solicitation the security conditions must be met before award of a contract and therefore, it is not mandatory to meet the security conditions before the bid closing date.

Q2. Could you please provide us with a copy of the floor plans of the relevant buildings, that clearly outlines the spaces to be cleaned? We would like to estimate the square footage of the area to be covered.

R2. Floor plans below, clean all areas except as defined in Annex A, Statement of Work, 23 Areas Not to be Entered at Anytime. Approximate building size, NHRC 10,970 sq. meters, PNWRC 2,300 sq. meters.

Q3. Re: dispensers, we noted during the site visit that there are some existing ones. Is the expectation that these would all be replaced? In any event, could you please provide us with a list of total number and types (i.e., soap, hand towel, toilet paper) of dispensers to be provided?

R3. Approximate minimum number of dispensers, toilet paper 19, paper towel 19, soap 18. As per Annex A, Statement of Work, 11 Cleaning Supplies and Equipment, "paper towel, toilet paper, hand soap and dispensers. Paper towel, soap and toilet paper type supplied must be consistent with current products brands and type. Any change by the Contractor must be pre-approved by the Site Authorities"

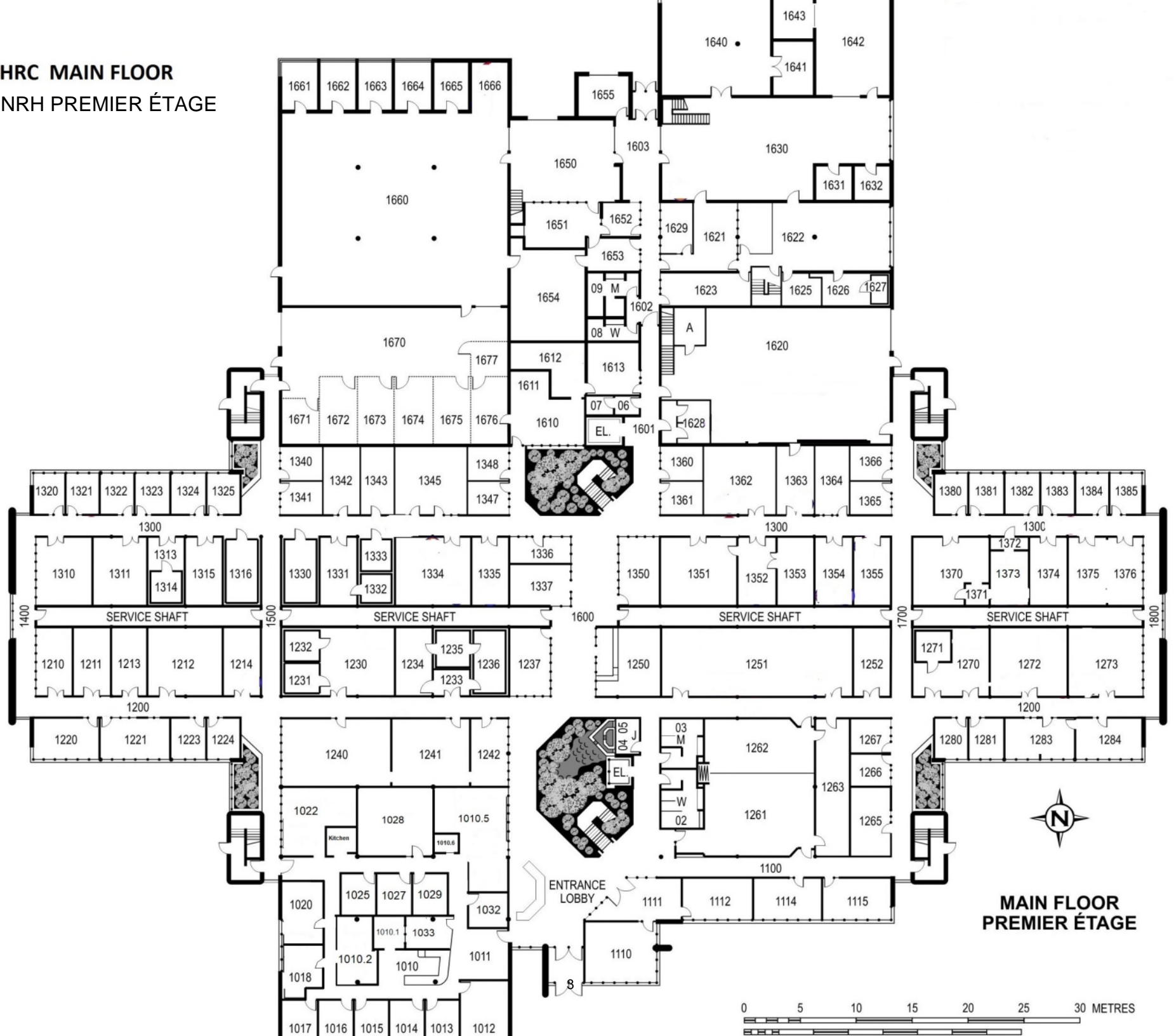
- Paper towel – White with leaf, extra soft 29 00 44
- Toilet paper – Mini Jumbo bath tissue 11 02 06 02
- Hand soap – Foam Soap 40 12 11

Q4. Are you able to provide us with rough estimates of usage of consumables over time, for example pre-Covid levels vs post-Covid levels? This will help us to determine volumes required based on consumption trends.

R4. As per Annex A, Statement of Work, 11 Cleaning Supplies and Equipment, it is the responsibility of the Contractor to supply all cleaning products (consumables) and equipment therefore the Site Authority does not track or record consumption of cleaning products, supplies and equipment. We have no data to provide.

All other terms and conditions of the Bid Solicitation remain the same.

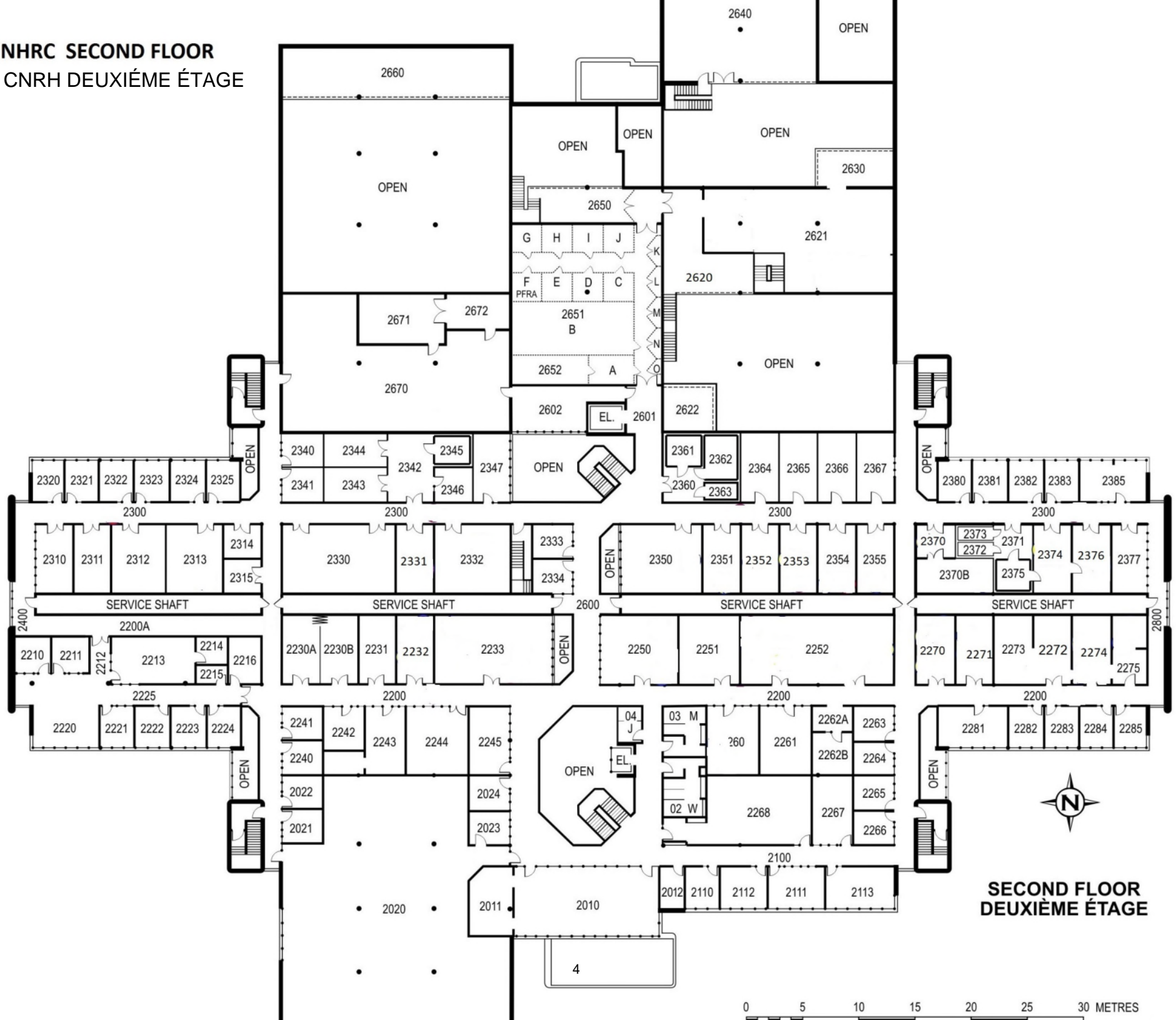

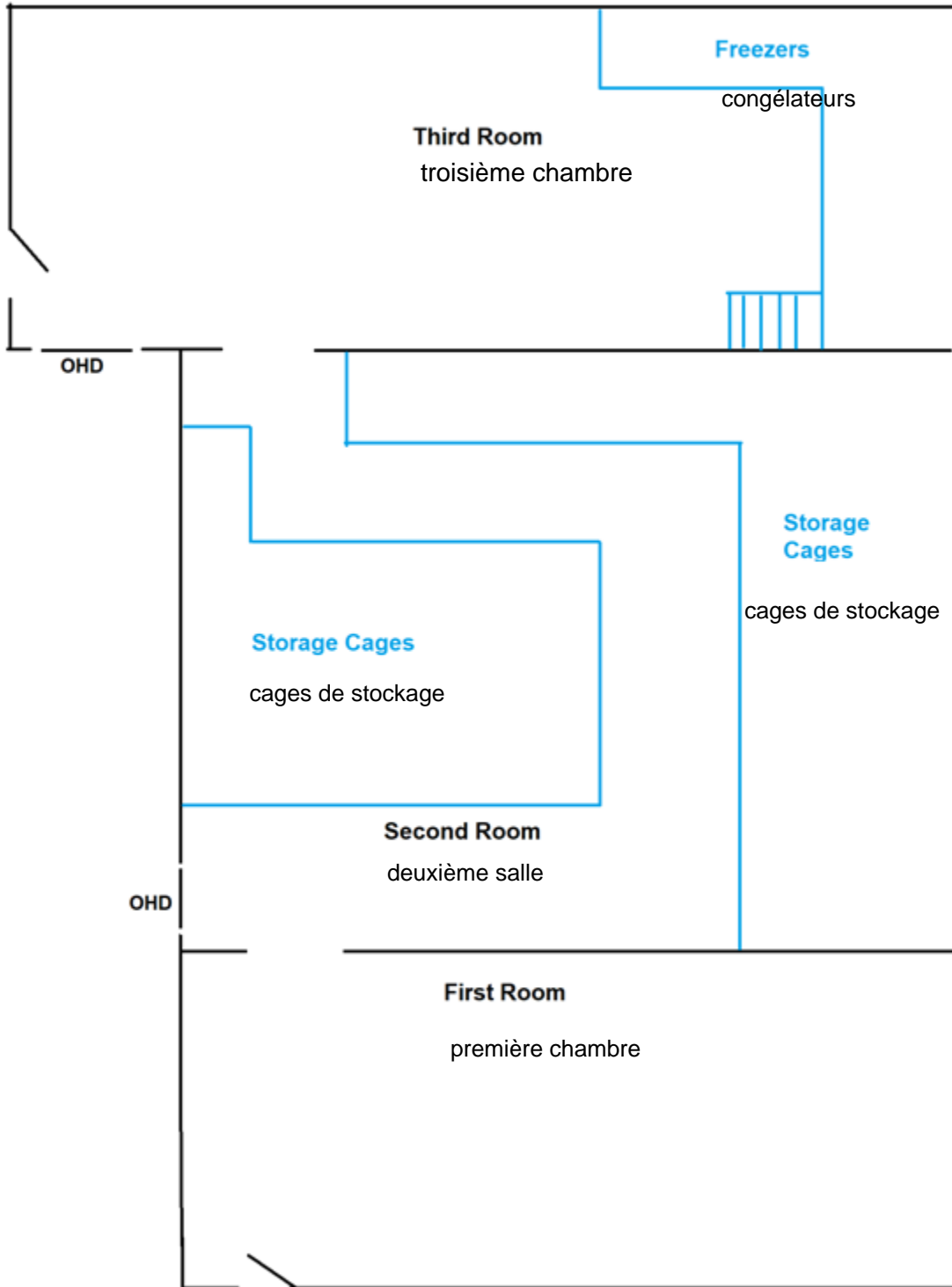
