1. Provide clarification and answers to questions from potential supplier

QUESTIONS AND ANSWERS:

Question 1	Corporate mandatory requirement MC2 states that bidders must be a Microsoft Certified Partner. Given that this requirement was issued under the Task-Based Informatics Professional Services (TBIPS) method of supply, and not Solutions-Based Informatics Professional Services (SBIPS), the Crown will not benefit from having a Bidder with the designation as as they provide no project oversight. On a standard TBIPS contract, vendors place resources and do not provide the services themselves. The Crown therefore receives no benefit from requiring a vendor to be a Microsoft Certified Partner. Bearing this in mind, would the Crown please remove MC2 in its entirety?
Answer 1	We have reviewed your request. The requirement remains unchanged.
