C. Questions and Answers

- **Q1**. Who is responsible for ensuring there are no nesting birds on the bridges prior to demolition?
- A1. PCA will be responsible for monitoring the bridges to watch for nests. Additionally, the project has been scheduled such that all birds should have left the nest by the time demolition begins. PCA will review prior to demolition.
- **Q2**. Is there any flexibility in the start and completion dates?
- A2. Not at this time. The start date is already as early as it can be due to various requirements around birds, bats, fish, and the Emergency Protection Order requirements. The completion date will also remain as December 2023 per the Stage 1 ITQ. Further details will be included in the Stage 2 documents.
- Q3. Do the bridges or roads have asphalt?
- A3. No, these are on gravel roads with clayey or granular embankments.

Q4. If we are filling out Stage 1 for both projects, do we need to use 4 separate projects as examples?

- A4. No, you can use the same 2 projects on each ITQ.
- **Q5**. Do we need to respond to both Stage 1 ITQ documents?
- **A5**. We recommend submitting ITQ for both projects, then you can decide once you see the drawing packages whether you want to bid on one or both, or neither. To qualify to bid on both bridge projects, ensure that you have filled out 2 separate ITQ packages; one says "Dixon Bridge Replacement" at the top of each page, and the other says "Walker Bridge Replacement"
