Question:

I have a question about the Scope of supply. Please define the scope of supply in the \$20,000 allowance for Atlas polar FSR under specification item 17.1. Will Atlas Polar look after everything in the spec item?

Answer:

It is the responsibility of the Contractor to confirm with the FSR what items in the 17.1 will be provided by the FSR under the allowance. If there are items in 17.1 that the FSR will not complete, the Contractor must quote on this work outside of the allowance. The FSR must sign the T2 form as per 17.1.1.2.
