1. Provide clarification and answers to questions from potential supplier

QUESTIONS AND ANSWERS:

Question 8	For Rated Corporate Criteria RC1, Transport Canada requires bidders to demonstrate their depth of corporate experience in delivering Power Apps billed days through the contracts used to support MC1. However, some of the parameters in MC1 are restrictive and could prevent bidders from referencing otherwise relevant Power Apps billed days through other contracts. As bidders will be providing copies of the contracts to demonstrate that days billed are relevant to RC1, would Transport Canada allow bidders to reference two contracts to demonstrate the Power Apps resource days billed, where only one contract must be from MC1?
Answer 8	We have reviewed your request. The requirement remains unchanged.
Question 9	Will Transport Canada agree to add the underlined wording for all levels of Business System Analyst (BSA) R2 rated criteria as follows? Yes / No
	"The Bidder should demonstrate that the proposed resource has a minimum of six (6) month of experience gathering requirements for system integration between Cloud to Ground and which clearly define rules for pulling, pushing, and sharing Protected B data or at least one similar data security standard equivalent used within the IT industry."

Question 14	We note that Canada has requested the bidder submit reference contracts. Due to client confidentiality, we are unable to share contracts without explicit permission from the reference clients. Furthermore, the contracts may not provide the level of detail Canada is seeking to ensure the services performed demonstrate the required experience. Would Canada consider accepting a letter from the reference clients that substantiates the services performed?

Question 15	Point Rated Criteria CR2 is requesting that the Bidder provide Statements of Work and Task Authorizations for contracts that outline roles and activities that support Power Apps solutions. However, Statements of Work and Task Authorizations often only include a short list of tasks that is not exhaustive and may not fully represent the scope of work that the Contractor's resources are performing. As such, we would like to respectfully enquire whether the Crown would accept a signed client reference letter that details the roles and activities the Bidder is performing with regards to supporting Power Apps solutions in lieu of copies of the Statements of work and Tasks authorizations
